CAREER PROFILE

During my civil service career spanning over 34 years, I have held several key positions in the Income Tax Department and in other Ministries in the Govt. of India. I have varied experience in the multifaceted field of tax administration; tax policy and planning; public administration; settlement of appeals, disputes and grievances; investigation; vigilance etc. Some of my achievements are highlighted below:

Experience in Income Tax Department

1. I joined the Indian Revenue Service in 1976. I was the topper of my batch. After successfully completing my foundational training at LBSNAA, Mussorie and professional training at National Academy of Direct Taxes in Nagpur, I held various positions in the cadre of Asst. Commissioner of Income Tax at Kolkata and Delhi involving tax assessment, collection, investigation and settlement of taxpayers grievances. I was judged as one of the five best probationers during my professional training.

- 2. I was promoted to the cadre of Joined Commissioner of Income Tax in July, 1993 and was posted as IAC (Appeals) in Kolkata. During 1993-95, I worked as Additional Commissioner of Income Tax in Delhi. During this period, I spent considerable period in settling public grievances and tax disputes of the salaried govt. employees.
- 3. On promotion as Commissioner of Income Tax in Oct. 2000, I worked as Commissioner of Income Tax (Appeals) in Delhi. I was the appellate authority for corporate, partnership firms as well as individual assessees. My job entailed dispute resolution between the department and the tax payers. The appellate orders passed by me in favour of the taxpayers were seldom contested by the Department, which demonstrated fairness and equitable nature of my judgments as Commissioner (Appeals).
- 4. I served as Administrative Commissioner of Income Tax in Delhi (2002-2006) and Kolkata (2006-2009). I was in administrative control of Salary and Central Charges and accorded highest priority to public grievances regarding non receipt of PAN, claim of refunds and interest, release of seized assets, waiver of interest, giving appeal effect etc. I also worked as Director of Income Tax (EXEMPTION) and my job entailed granting registration and exemption under Income Tax Act to Trusts, charitable and educational and other NGO.
- 5. On promotion to the cadre of Chief Commissioner of Income Tax (Equivalent to the Additional Secretary to the Govt. of India) in April 2009, I was posted as Chief Commissioner of Income Tax -XI in Kolkata. I am looking after the tax administration of my jurisdictional region. Redressal of tax payers grievances, waiver of interest and compounding of offences, deciding references to High Court and Supreme Court in Departmental appeals; and supervision of Administrative Commissioners and Appellate Commissioners are important components of my job.

- In 1988, I was posted on deputation as Director in the Department of Economic Affairs (Economic Division) in the Ministry of Finance. During my tenure of 5 years in the DEA, I was responsible for preparation of the Economic Surveys, Budget forecastings and handling of the budget proposals on Direct Taxes received from various trade Associations. I was a member of the Working Group for implementation of the Chelliah Committee Report on Tax Reforms. I also had the occasion to attend meetings on Public Finance with eminent economists and IMF/World Bank team of officials.
- 2. In 1995, I again went on deputation to the Central Board of Direct Taxes, Department of Revenue. As Director (Investigation), CBDT, I handled various scam related cases. As Director (Audit & PAC), I handled all work relating to the C& AG and Public Accounts Committee.

Other administrative experiences

- 1. As a member of the Scam Monitoring Committee set up by the Hon'ble Supreme Court in 1997, I visited several countries for conducting investigation in scam related cases and held meetings with the Revenue officers in USA, UK, Canada, Japan, Hong Kong, Singapore, Thailand etc.
- 2. As a member of Review Committee for Departmental publications, I have reviewed and edited Tax Payers Series and books.
- 3. Nominated as Examiner and Observer for Departmental Examination of Income Tax Officer,
