- 1) Age would be reckoned as on 1st April, 2007.
- 2) Age is relaxable by 5 years in the case of SC/ST candidates and by 3 years for OBC candidates.
- 3) In case of Assistants, appropriate relaxation in age would be considered for deserving candidates for those serving for Central Government or public sector insurance company if they were recruited through a recognized examination for selection.

Other conditions/instructions:

- 1. Typed copy of the bio-data in the format, duly signed, to be sent with two passport size photographs (one to be pasted on the application), attested copies of certificates, testimonials and a demand draft from the Nationalized bank for Rs.500/- (non-refundable) in the name of the Authority (in favour of "Insurance Regulatory and Development Authority") payable at Hyderabad should reach the Authority by 10th July, 2007 to the above address. Candidates belonging to SC/ST/OBC categories are exempt from the fee.
- 2. The approximate gross salary in the minimum of Pay scale of Deputy Director will be Rs.35990/- in case of Assistant Director, it would be Rs.19846/- and for Assistants Rs.14486 (inclusive of Basic pay, DA, HRA (8.5% of Basic pay), and CCA & FA).
- The pay scales carry inter alia usual allowances like DA/HRA/CCA, Attractive Actuarial Qualification Allowance and other perquisites. The selected candidates will be eligible for PF, gratuity, GSLIS, Leased accommodation, conveyance allowance, Medical facilities, Housing Loan and other facilities as per IRDA's existing rules/regulations
- 4. Persons serving in State/Central Governments and Public Sector Undertakings should apply through proper channel. However, they can forward an advance copy to the Authority.
- 5. The selected candidates will be posted in the office of the Authority located in Hyderabad and at such other places where the Authority may establish its offices.
- 6. Screening committee constituted by the Authority will be examining the applications and candidates qualifying the criteria will be considered to be called for the test/interview/selection. Mere eligibility does not confer any right on the applicant to be called for the selection. Reimbursement of traveling expenses will be admissible only to unemployed outstation candidates belonging only to SC/ST/OBC candidates subject to second class train fare / ordinary bus fare.
- 7. Incomplete applications are liable to be rejected.
- 8. The Authority has the right to reject all or any application without assigning any reason therefor.
- 9. In respect of Deputy Director and Assistant Directors the Authority may consider appointment on deputation/contract basis.
- 10. The Authority, in exceptional cases, can consider appointment in the next higher grade or offer a post in the lower grade.
- 11. Chairman of the Authority, can consider relaxation in any or all of the clauses in particular with regard to experience in case of deserving candidates.
- 12. If at any stage, it is found that the information furnished in the application is false / incorrect or if according to the Authority, the candidate does not satisfy the eligibility criteria, his/her candidature/appointment is liable to be cancelled/terminated at any stage.
- 13. The application should be accompanied by the following undertaking:

"I hereby declare that all the statements made in this application are true, complete and correct to the best of my knowledge and belief. I understand that if at any stage, it is found that any information given in this application is false / incorrect or that do not satisfy the eligibility criteria, my candidature / appointment is liable to be cancelled/terminated.
