Terms and Conditions

PART B

Important Terms and Definitions

B.1. DEFINITIONS

In this Policy, unless the context requires otherwise, the following words and expressions shall have the meaning ascribed to them respectively herein below:

Age shall be age of Life Assured at entry as at last birthday i.e. the Age in completed years and is stated in the Policy Schedule.

<u>Eligible Person</u> means the Policyholder, including assignees under Section 38 of the Insurance Act, 1938, or nominees under Section 39 of the Insurance Act, 1938, or proving executors of administration or other legal representatives, as per the applicable Regulations.

Life Assured shall mean the person named as such in the Policy Schedule on whose name this Policy is effected.

Nominee means a person who is named as the Nominee in the proposal form or subsequently changed by an endorsement as per section 39 of the Insurance Act, 1938, who has the right to give a valid discharge to the policy monies in case of death of the Life Assured before the maturity of the Policy.

Policy means this plan, the operation, regulation and management of which is governed by the documents comprising these terms and conditions, the Annexure, the signed Proposal Form, the signed benefit illustration, the Policy Schedule and any attached endorsements or supplements together with all addendums.

<u>Policyholder</u> shall mean the owner of this Policy and is referred to as the proposer in the proposal form and is named as such in the Policy Schedule.

<u>Policy Commencement Date</u> means the Date, Month, and Year the Policy comes into effect and is specified as such in the Policy Schedule.

Policy Maturity Date means the date of completion of the Policy Term as specified in the Policy Schedule.

<u>Policy Schedule</u> means the Schedule issued by the Company that sets out the details of this Policy and is attached to and forming part of this Policy.

<u>Policy Term</u> means the tenure of this Policy during which the contractual benefits are payable and is specified as such in the Policy Schedule.

<u>Policy Year</u> means a period of twelve (12) consecutive months starting from the Policy Commencement Date and ending on the day immediately preceding the following Policy anniversary date and each subsequent period of twelve (12) consecutive months thereafter.

<u>Premium</u> means the contractual amount payable by the Policyholder in a Policy Year on the due date as set out in the Policy Schedule to secure the benefits under this Policy. Applicable service tax, cess and other levies if any are payable in addition.

<u>Premium Payment Term (PPT)</u> means the period in years during the Policy Term in which Premiums are payable by the Policyholder under the Policy, as specified in the Policy Schedule.



<u>Regulations</u> mean the laws and Regulations in effect from time to time and applicable to this Policy, including without limitation the Regulations and directions issued by the Regulatory Authority from time to time. The applicable Regulation shall form a part and parcel of the terms and conditions, and the terms and conditions shall be read along with the Regulation.

Regulatory Authority means the Insurance Regulatory and Development Authority of India (IRDAI) or such other authority (ies) as may be designated under the applicable laws and Regulations.

Reinstatement means restoration of the Policy, which was discontinued due to non-payment of the Premium, by the Company with all the benefits mentioned in the terms and conditions, with or without rider benefits, if any upon receipt of all the Premiums due and other charge/late fee if any, as per the terms and conditions of the Policy, upon being satisfied as to the continued insurability of the Life Assured/Policyholder on the basis of the information, documents and reports furnished by the Policyholder, in accordance with the board approved underwriting guidelines.

<u>Rider</u> means the Rider/s, if any, which provides additional cover which can be opted by the Life Assured/Policy Holder and issued by the Company, attached to and forming part of this Policy.

<u>Rider Benefits</u> means the amount of Benefit payable on a specified event offered under the Rider and is allowed as add-on benefit to main benefit and is mentioned in the Rider Policy.

<u>Rider Endorsement Letter</u> means the letter issued by the Company on a Policy Anniversary date to which the Rider Policy is attached to and forms a part of the Policy.

<u>Risk Commencement Date</u> means the date from which the insurance coverage under this Policy commences and as specified in the Policy Schedule.

<u>Sum Assured on Death</u> means an absolute amount of benefit which is guaranteed to become payable on the event of death of the Life Assured in accordance with the terms and conditions of the Policy and is specified as such in the Policy Schedule or such amount as may be endorsed on the Policy.

<u>Sum Assured on Maturity</u> means the an absolute amount of benefit specified as such in the Policy Schedule or such amount as may be endorsed on the Policy which is guaranteed to become payable on Policy maturity date, if the Life Assured has survived on such date and all due Premiums have been received by Us and in accordance with the terms and conditions of the Policy.

<u>Surrender</u> means complete withdrawal/termination of the entire Policy by the Policyholder.

<u>Surrender Value</u> means an amount, if any, that becomes payable in case of Surrender in accordance with the terms and conditions of the Policy.

"We", "Us", "Our" and "Company" refers to Exide Life Insurance Company Limited.

"You" and "Your" refers to the person named as the Policyholder.



PART C	
Product Core Benefits	

BENEFITS PAYABLE UNDER THIS POLICY

- **C.1. Life Cover:** Subject to terms and conditions of this Policy and the Policy remaining in full force and effect, in the event of unfortunate demise of the Life Assured after Risk Commencement Date but before Policy Maturity Date, the company shall pay Sum Assured on Death plus vested bonus (if any) plus applicable Guaranteed Terminal Additions (if any) to the Eligible Person after deducting the Premiums, if any due for the Policy year of demise/death.
- C.1.1. **Sum Assured on Death**: Sum Assured on Death is as mentioned in the Policy Schedule and is chosen from the options mentioned below. It is calculated as higher of multiple of Annualized premium excluding service tax, rider premium/extra premium, if any or 'Sum Assured on Maturity'. Apart from what is stated above there is no absolute amount assured to be paid on death in this product. The multiple of Sum Assured on death is as per tables below:

^{*}Premium excludes service tax, rider premium/extra premium, if any.

Under no circumstances, the Life Cover will be less than the following:

<u>Limited Premium Payment Term (5 Years):</u> 105% of contractual Premiums paid till date of Death excluding service tax, rider premiums and premiums paid for extra mortality loading, if any.

Single Premium: 125% of contractual Premium paid excluding service tax, rider premiums and premiums paid for extra

<u>single Premium:</u> 125% of contractual Premium paid excluding service tax, rider premiums and premiums paid for extra mortality loading, if any.

- **C.2. Maturity Benefit:** Subject to the terms and conditions of this Policy and the Policy remaining in force and effect on the Policy Maturity Date, the Company shall pay to the Eligible Person the following benefits on Policy Maturity Date:
 - C.1.1. Sum Assured on Maturity under this Policy
 - C.1.2. Guaranteed Terminal Additions
 - C.1.3. Simple Reversionary Bonus, if any

Subject to the payment of all the due premiums, the Maturity benefit shall not be less than 101% of the contractual base premium payable under the policy, excluding service tax, rider premiums and premiums paid for extra mortality loading.

C.3. Guaranteed Terminal Additions: The Policy provides Guaranteed Terminal Addition as a percentage of 'Sum Assured on Maturity'. These Guarantee Terminal Additions are applicable from the end of 5th Policy Year till last Policy Year. The Guaranteed Terminal Addition rate applicable at the end of the policy year is as follows:

- **C.4. Bonus-Participation in Surplus:** This Policy participates in the surplus of the participating fund and bonus, subject to availability of surplus, will be declared by the Company in the form of Simple Reversionary bonus which will be a percentage of the 'Sum Assured on Maturity'. The company might also declare terminal bonus in order to distribute the remaining surplus if any and the same will be payable on death or maturity once it is declared.
- **C.5. Rider Benefits:** If any Riders are opted and attached to this Policy as specified in the Policy Schedule or in the Rider Endorsement Letter, the Rider Benefit shall become eligible subject to the Rider Terms and conditions.

C.6. PREMIUM UNDER THIS POLICY

C.6.1. Payment of Premiums: This Policy is issued subject to the Policyholder making prompt and regular payment of Premium for the Premium Payment Term as mentioned in the Policy Schedule and it shall be the responsibility of the Policyholder to ensure prompt and regular payment of the Premium.

In the event the Policyholder makes a choice of monthly premium payment mode, three (3) months premiums shall be collected in advance on the date of commencement of the policy and adjusted towards the policy only on the due dates. These advance premiums shall be non-refundable, except in case of Free Look Cancellation of this policy.

C.6.2. Grace Period: A Grace Period of fifteen (15) days for monthly mode and thirty (30) days for all other modes from the Premium payment due date will be allowed for payments of each Premium. The Regular Premiums are payable on the due date for payment and in any case not later than the Grace Period. During the Grace Period, the Policy shall continue to be in force for availing the Life Cover. Any unpaid Premium is deductible from the Benefits that may accrue during the Grace Period. If the Premiums due are not paid within the Grace Period, the Policy will be eligible for Non-Forfeiture options explained in clause D.3.

C.7. Exclusions:

- **C.7.1.** If Age of the Life Assured is greater than or equal to 12 years, the life cover under the Policy will commence immediately from the date of commencement of the Policy. If the Age of Life Assured is less than 12 years, the life cover under the Policy will commence from the completion of two Policy Years. During this period, if the Life Assured dies then the Life Cover shall be restricted to refund of Premiums without interest.
- **C.7.2. Suicide:** If the Life Assured commits suicide for any reason, while sane or insane, within one year from the date of commencement of risk or within one year from the date of Reinstatement of the lapsed Policy, as the case may be, the Policy shall terminate with immediate effect and the Company will not be liable to pay the benefits under the Policy other than what is specified below:
 - If death occurs within one year from the date of commencement: 80% of Premium paid, excluding service tax provided the Policy is in force shall be paid to the Eligible Person.
 - If death occurs within one year from the date of Reinstatement: Higher of 80% of Premium paid, excluding service tax or Surrender Value as available as on the date of death shall be paid to the Eliqible Person.



PART D

Policy Servicing Related Aspects

D.1. Free Look Provisions: The Policyholder shall have a period of 15 days (30 days if the Policy is sourced through Distance Marketing#) from the date of receipt of the Policy document to review the terms and conditions of this Policy and if the Policyholder disagrees with any of the terms and conditions, he/she has the option to return the Policy stating the reasons for the objections upon which the Company shall return the Premium paid subject to deduction of a proportionate risk Premium for the period of insurance cover in addition to the expenses incurred on medical examination (if any) and the stamp duty charges. All Benefits and rights under this Policy shall immediately stand terminated at the cancellation of the Policy.

Distance Marketing includes solicitation through all modes other than in person.

D.2. Reinstatement of the Policy:

- D.2.1. Subject to the approval of the Company and the prevailing board approved underwriting policy, this Policy, if lapsed, may be reinstated for full benefits before the Policy Maturity Date but within two years from the due date for payment of the first unpaid Premium provided that;
 - D.2.1.1. This Policy has not been surrendered for cash;
 - D.2.1.2. No claim has arisen under this Policy.
 - D.2.1.3. Where required by the Company, a written application for Reinstatement is received from the Policyholder by the Company, together with evidence of insurability and health of the Life Assured, to the satisfaction of the Company; and
 - D.2.1.4. All amounts necessary to reinstate this Policy including all arrears Premiums with interest/reinstatement charge as levied by the Company from time to time.
- D.2.2. Notwithstanding anything to the contrary contained elsewhere in this Policy, the Company reserves the right to reinstate the lapsed Policy either on its original terms and conditions or on such other or modified terms and conditions as the Company may specify or to reject the Reinstatement. If needed the Company may refer it to its medical examiner in deciding on Reinstatement of lapsed Policy. Subject to the provisions of Clauses D.2.1 above, the Reinstatement shall come into effect on the date when the Company specifically communicates it in writing to the Policyholder.
- D.2.3. Since the Company shall be relying on the statements made by the Policyholder/Life Assured to the Company and to its medical examiner in deciding on Reinstatement of a lapsed Policy, if any incorrect or untrue statement has been made or any material fact has been suppressed, the Company shall be entitled to cancel the Reinstatement of this Policy or repudiate the claim, if any, arising after such Reinstatement and the Policyholder shall not be entitled to receive any amounts paid under this Policy including the amounts paid towards such Reinstatement.

D.3. Non-Forfeiture options upon Non-Payment of Premiums:

- (i) If one full year's Premiums has not been paid, the Policy will lapse until the Policy is reinstated for full Benefits within two years from the first unpaid Premium due date. No Benefits will be paid to the Policyholder or the Eligible Person if the Policy is in Lapse stage.
- (ii) A Lapse Policy will cease to participate in the profits from the date on which the Premium was due but not paid.
- (iii) A single Premium Policy will never lapse.

For Policies with Limited Premium Payment Term (5 years), if at least one full year's Premium has been paid and less than two full years' Premiums have been paid, the Policyholder will be eligible for guaranteed surrender value as explained in section D.3.2.2. However in case of unfortunate demise of the policyholder before acquiring the Reduced Paid-up Value as explained in section D.3.1, the applicable Surrender Value shall be payable immediately on death and the Policy terminates.

For single Premium Policies, the Policyholder will be eligible for Guaranteed Surrender Value immediately at Policy inception as explained in section D.3.2.2



For Policies with Limited Premium Payment Term (5 years), if at least two full years' Premiums have been paid, and if any subsequent Premium due has not been paid, the Policyholder will be eligible for reduced paid-up value as explained in section D.3.1.2 and Surrender Value as explained in section D.3.2.1.

D.3.1. Reduced Paid-up Value

- D.3.1.1. For Policies with Limited Premium Payment Term (5 years), if at least one full year's Premium has been paid and less than two full years' Premiums have been paid, the Eligible Person will be eligible for Life Cover which will be equal to Surrender Value as applicable and the Policy terminates.
- D.3.1.2. For Policies with Limited Premium Payment Term (5 years), if at least two full years' Premiums have been paid and no further due Premiums are paid, then the Policy will be eligible for a non-forfeiture Benefit which shall be a Reduced Paidup Value. The minimum amount of the Reduced Paid-up Value is shown below:

In case of unfortunate demise of Life Assured:

Guaranteed Terminal Additions are applicable only if death occurs after completion of 5th Policy Year.

In case of Maturity Benefit:

- t = Number of installments of premiums paid
- n = Total number of installments of premiums payable under the Policy

A Reduced Paid-up Policy will cease to participate in the profits/surplus of the fund from the date on which the Premium was due but not paid.

Reduced Paid-up Benefit shall be payable on earlier of death of Life Assured or Policy Maturity Date as specified in the Policy Schedule.

D.3.2. Surrender of the Policy: For Policies with Limited Premium Payment Term (5 years), if at least one full year's Premium is paid the Policy can be surrendered. For single Premium Policies, the Policy can be surrendered anytime during the Policy Term. The Policy cannot be surrendered after the death of the Life Assured. Upon payment of the Surrender Value, the Policy shall stand terminated with no further Benefits payable under the Policy and the Company shall be relieved and discharged from all obligations under this Policy thereafter.

The Surrender Value is payable immediately on Surrender or at the end of the second policy year, whichever is later.

- **D.3.2.1. Surrender Value:** The Policy acquires a Surrender Value which is higher of Guaranteed Surrender Value or Special Surrender Value.
- D.3.2.2. <u>Guaranteed Surrender Value (GSV)</u>: For Policies with Limited Premium Payment Term (5 years), if at least one full year's Premium has been paid, the Policy acquires a Guaranteed Surrender Value. For single Premium Policies, the Policy acquires Guaranteed Surrender Value at Policy inception. The Guaranteed Surrender Value will be the sum of the following
 - a) GSV as a percentage of Premiums paid: GSV factor 1 multiplied by the total amount of Premiums paid excluding the Premium for extra mortality rating if any, and
 - b) GSV as a percentage of vested bonus: GSV factor 2 multiplied by the total vested bonus, if any.



The Guaranteed Surrender Value factors increase with the Policy duration and are provided in the table below:

D.3.2.3. Special Surrender Value: If the conditions as per section D.3.2. have been fulfilled, for Policies with Limited Premium Payment Term (5 years) wherein at least two full years' Premium have been paid and for single Premium Policies any time during the Policy Term, the Policy will acquire a Special Surrender Value. The Special Surrender Value will be quoted



only on receipt of a Surrender request which shall be determined by the Company from time to time and is not guaranteed.

The Surrender Values and Non-forfeiture provisions apply only to the Base Policy mentioned in the Schedule and not to any Riders.

D.4. Policy Loan: For Policies with Limited Premium Payment Term (5 years), at any time after two full years' Premiums have been paid and at any time after completion of two full Policy Years, and for single Premium Policies, anytime during the Policy Term and if any Surrender Value is available under the Policy, the Policyholder may obtain a loan on the sole security of the Policy and on its proper assignment to the Company. The maximum amount of loan that will be advanced at any one time or more than one time shall not exceed 60% of the available Special Surrender Value and provided that the amount of the loan is not less that Rs.1000/-. The rates of interest payable on the loan and the other terms and conditions of the loan shall be as determined by the Company from time to time and will be subject to IRDAI's approval. All loans within the permissible limits will be granted after deducting any previous loan with interest. All outstanding loan and interest thereon shall be deducted from any Benefits payable under the Policy. Except in case of in-force or fully paid-up policies, if at any point of time, the loan along with outstanding accrued interest exceeds the value of Benefits payable under the Policy, the Policy will be foreclosed and no Benefits will be payable. Any payment made by the Policyholder in the Policy will first be utilized to repay the Policy Loan and then for any Premiums due, if any. The minimum amount of Policy Loan that can be repaid at every instance shall be Rs. 500 or total outstanding loan plus interest whichever is lower.



PART E

All the applicable Charges, Fund Name, Fund Options etc. (Applicable especially for ULIP Policies)

E.1. Not Applicable as this is a Non-linked individual product.



PART F

General Terms and Conditions

- **F.1. Forfeiture in certain events:** In issuing this Policy, the Company has relied on, and may rely on, accuracy and completeness of the information provided by the Proposer/Life Assured and any other declarations or statements made or as may be made hereafter, by the Policyholder/Life Assured. In case of fraud or misrepresentation, the Policy shall be cancelled immediately by paying the Surrender Value, subject to the fraud or misrepresentation being established by the Company in accordance with Section 45 of the Insurance Act, 1938 as applicable.
- **F.2. Admission of Age:** The Age of the Life Assured has been admitted on the basis of the declaration made by the Policyholder / Life Assured in the Proposal form and/or in any document/statement based on which this Policy has been issued. If the Age of the Life Assured is found to be different from that declared, the Company may, adjust the Premiums and/or the Benefits under this Policy and/or recover the applicable balance amounts, if any, as it deems fit. This Policy shall however become void from commencement, if the Age of the Life Assured at the Policy Commencement Date is found to be higher than the maximum or lower than the minimum entry Age that was permissible under this Policy at the time of its issue and the amounts received under this Policy shall be liable to be forfeited by the Policyholder in favour of the Company at the Company's option by paying the Surrender Value (as applicable).

F.3. Payment of Benefits

- F.3.1. Payment of the Benefits under this Policy shall be subject to deduction of any indebtedness arising out of outstanding Policy loans, interest due on such loans etc.
- F.3.2. Payment of all the Benefits as shown in the Policy Schedule shall be subject to receipt by the Company of proof to its satisfaction;
- F.3.2.1. of the Benefits having become payable as set out in this Policy; and
- F.3.2.2. of the title of the person or persons claiming the Benefits; and
- F.3.2.3. of the correctness of the Age of the Life Assured as stated in the Proposal, if not previously admitted.

F.4. Mode of payment of Benefits

- F.4.1. All Benefits and other sums under this Policy shall be payable in the manner and currency allowed/permitted under the Regulations and shall be payable by account payee cheque or other permissible modes.
- F.4.2. The Company shall pay the applicable Benefits and other sums payable under this Policy. Any discharge given by the Eligible Person, or by any person authorized by the Eligible Person in writing in respect of the Benefits or the sums payable under this Policy shall constitute a valid discharge to the Company in respect of such payment. The Company's liability under the Policy shall be discharged by such payment and the Company shall not be required to see the utilization of the monies so paid.
- F.4.3. Apart from the benefits mentioned hereinabove in part C the Company shall not be liable to pay any other benefits to the Eligible Person.

F.5. Requirements for maturity claims and death claims

- F.5.1. In the event of a claim for Maturity Benefit or Life Cover arising under this Policy, the Eligible Person shall intimate to the Company in writing of the claim and provide the following documents to the Company within 60 days of the claim arising, to enable the Company to process the claim:
- F.5.1.1. In case of maturity claims
 - (i) Original Policy document; and
 - (ii) Discharge Form
 - (iii) Self attested ID Proof, and
 - (iv) Bank account details along with IFSC code (payment would be made vide NEFT only) in case there is a change in the bank details already provided.



- F.5.1.2. In case of death claims, except death claims arising out of accidents or unnatural deaths
 - (i) Death Certificate, in original, issued by the competent authority;
 - (ii) Policy document, in original;
 - (iii) Medical Cause of Death certificate, issued by doctor certifying death.
 - (iv) Identification proof (bearing photo) of person receiving the Benefit and the Life Assured.
 - (v) Medical treatment records (discharge summary / death summary, investigation reports, etc) if Life Assured has taken treatment for illness leading to his/her death.
 - (vi) Bank account details of the claimant along with IFSC code (payment would be made vide NEFT only)
- F.5.1.3. In case of death claims arising out of accidents or unnatural deaths
 - (i) Death Certificate, in original, issued by the competent authority;
 - (ii) Policy document, in original;
 - (iii) Identification proof (bearing photo) of person receiving the Benefit and the Life Assured.
 - (iv) First Information Report, Inquest and the Final Investigation Report thereof, duly attested by concerned jurisdictional Police Official.
 - (v) Post Mortem Report duly attested by the concerned officials.
 - (vi) Bank account details of the claimant along with IFSC code (payment would be made vide NEFT only)
- F.5.1.4. Notwithstanding anything contained in Clause F.5.1.2 and F.5.1.3 above, depending upon the cause or nature of the claim, the Company reserves the right to call for any other and/or additional documents or information, including documents/information concerning the title of the person claiming the Life Cover under this Policy, to the satisfaction of the Company, for processing of the claim.
- F.5.1.5. Delay in intimation of claim or submission of documents for the reasons beyond the control of the insured/claimant may be condoned by the Company.
- **F.6. Assignment:** Assignment should be in accordance with provisions of sec 38 of the Insurance Act 1938 as amended from time to time.

- **F.7. Nomination:** Nomination should be in accordance with provisions of sec 39 of the Insurance Act 1938 as amended from time to time.
 - [A Leaflet containing the simplified version of the provisions of Section 39 is enclosed in Annexure (2) for reference]
- **F.8. Review, revision**: The Company reserves the right to review, revise, delete and/ or alter any of the terms and conditions of this Policy, including without limiting the Benefits, the Premiums with the prior approval of the Regulatory Authority.
- **F.9. Release and discharge:** The Policy will terminate automatically on payment of the Surrender Value, Life Cover, maturity benefit, on lapse of the Policy or on the happening of the events that the Policy reads specifically that the Policy shall terminate, as the case may be, and the Company will be relieved and discharged from all obligations under this Policy thereafter.
- **F.10.** Taxes, duties and levies and disclosure of information: This Policy, and the Benefits and the Surrender Value payable under this Policy shall be subject to the Regulations, including taxation laws in effect from time to time. All taxes, duties or levies including without limitation any value added, service tax or other taxes (collectively "Taxes") as may be imposed now or in future by any authority on the Premiums, charges and Benefits shall be borne and paid by the Policyholder or the Eligible Person, as the case may be or deducted by the Company from the Premium received or Benefits payable. The Premium and other sums payable under or in relation to the Policy do not include the Taxes. The persons receiving the Benefits shall be solely liable for complying with all the applicable provisions of the Regulations, including taxation laws, and payment of all applicable Taxes. In any case where the Company is obliged to account to the



revenue authorities for any Taxes applicable to this Policy or the Benefits payable under this Policy, the Company shall be entitled to deduct such Taxes from any sum payable under this Policy, and deposit the amount so deducted with the appropriate governmental or regulatory authorities. In any case where the Company is obliged to disclose to the revenue or other regulatory authorities any information concerning the Policy, including information concerning the Premium and the Benefits under this Policy, the Company shall be entitled to disclose the required information to the appropriate governmental or regulatory authorities.

- **F.11. Notice by the Company under the Policy:** Any of the notices required to be issued in terms of this Policy may be issued, either by issuing individual notices to the Policyholder, including by electronic mail and/or facsimile, or by issuing a general notice, including by publishing such notices in newspapers and/or on the Company's website.
- **F.12. Entire Contract:** This Policy comprises the terms and conditions set forth in this Policy document, the Policy Schedule, and the endorsements, if any, made on or applicable to this Policy, which shall form an integral part and the entire contract evidenced by this Policy. The liability of the Company is at all times subject to the terms and conditions of this Policy and the endorsements made from time to time.

F.13. Risk Factors

- a) This is a Non-Linked, Participating Life Insurance Product.
- b) Exide Life Insurance Company Limited is only the name of the Insurance Company and the name of the product does not in any way indicate the quality of the product, its future prospects or returns.
- **F.14. Governing Law and Jurisdiction:** This Policy shall be governed by and interpreted in accordance with the laws of India. All actions, suits and proceedings under this Policy shall be subject to the exclusive jurisdiction of the courts of law within whose territorial jurisdiction the registered office of the Company is situated. No action in law or equity shall be brought against the Company to enforce any claim under this Policy, unless the Policyholder has filed with the Company a claim together with all the required documents, in accordance with the requirements of this Policy and complied with the requirements of the Company, at least 60 days prior to the institution of such action.
- F.15. Prohibition of Rebate: Under the provisions of Section 41 of the Insurance Act, 1938
- F.15.1. No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the Premium shown on the Policy, nor shall any person taking out or renewing or continuing a Policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer.
- F.15.2. Any person making default in complying with the provisions of this section shall be punishable with fine which may extend to ten lakh rupees.

- **G.1.2.** Fraud, Misrepresentation and forfeiture: Fraud, Misrepresentation and forfeiture would be dealt with in accordance with provisions of Sec 45 of the Insurance Act 1938 as amended from time to time.

Annexure - (1)

Section 38 - Assignment and Transfer of Insurance Policies

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

- 01. This policy may be transferred/assigned, wholly or in part, with or without consideration.
- 02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
- 03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
- 04. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
- 05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
- 06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
- 07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
- 08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
- 09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
- a. not bonafide or
- b. not in the interest of the policyholder or
- c. not in public interest or
- d. is for the purpose of trading of the insurance policy.
- 10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
- 11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
- 12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
- 13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
- a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR



- b. where the transfer or assignment is made upon condition that
- i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
- ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

- 14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
- a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
- b. may institute any proceedings in relation to the policy
- c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
- 15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Ordinance, 2014 shall not be affected by this section.

Annexure - (2)

Section 39 - Nomination by policyholder

Nomination of a life insurance policy should be in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

- 01. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
- 02. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
- 03. Nomination can be made at any time before the maturity of the policy.
- 04. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
- 05. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
- 06. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
- 07. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
- 08. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
- 09. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
- 10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
- 11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
- 12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).
- 13. Where the policyholder whose life is insured nominates his



- a. parents or
- b. spouse or
- c. children or
- d. spouse and children
- e. or any of them

the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.

- 14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
- 15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Ordinance, 2014 (i.e 26.12.2014).
- 16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
- 17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Laws (Ordinance) 2014, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

Annexure – (3)

Section 45 - Policy shall not be called in question on the ground of mis-statement after three years

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended from time to time. The extant provisions in this regard are as follows:

- 01. No Policy of Life Insurance shall be called in question on any ground whatsoever after expiry of 3 yrs from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policy

whichever is later.

- 02. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from
 - a. the date of issuance of policy or
 - b. the date of commencement of risk or
 - c. the date of revival of policy or
 - d. the date of rider to the policy

whichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

- 03. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:
 - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
 - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
 - c. Any other act fitted to deceive; and
 - d. Any such act or omission as the law specifically declares to be fraudulent.
- 04. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.
- 05. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress



the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.

- 06. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.
- 07. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.
- 08. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.
- 09. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
