#### A. Definitions

The terms defined below have the meanings given to them wherever they appear in the Policy:

- 1. Age means age at last birthday as specified in the Schedule.
- 2. Annual Premium means the amount specified in the Schedule.
- 3. Annualised Premium means the amount specified in the Schedule.
- 4. Appointee means the person named as such in the Schedule and as mentioned in Section 39 of the Insurance Act, 1938, as amended from time to time, to receive the death benefit and give a valid discharge to Us on behalf of the Nominee in the event of death of the Insured when the Nominee is less than Age 18.
- 5. Claimant shall mean the Policyholder if he is different from the Insured or the Nominee or assignee, and where there is no assignment or nomination in existence, the legal heirs of the Policyholder as the case may be.
- 6. Death Benefit means the amount which is payable in accordance with Part C.
- 7. Death Sum Assured means the amount which is payable in accordance with Part C.
- 8. Grace Period means a period of thirty (30) days commencing from the date on which the Regular Premium was due.
- 9. Insured means the person named as the insured in the Schedule on whose life this Policy is effected.
- 10. IRDA of India or IRDAI means Insurance Regulatory and Development Authority of India established under the IRDA Act, 1999.
- 11. Maturity Benefit means the amount payable, if any, in accordance with Part C.
- 12. Maturity Date means the date on which the Policy matures, as specified in the Schedule.
- 13. Maturity Sum Assured means the amount which is payable in accordance with Part C.
- 14. Medical Practitioner means a person who holds a valid registration from the medical council of any state of India or Medical Council of India or Council for Indian Medicine or for Homeopathy set up by the Government of India or a State Government and is thereby entitled to practice medicine within its jurisdiction and is acting within the scope and jurisdiction of his license. Medical Practitioner shall not include:
  - i. Your spouse, father (including step father), mother (including step mother), son (including step son), son's wife, daughter (including step daughter), daughter's husband, brother (including step brother) and Sister (including step sister), or;



- ii. You or the Insured
- 15. Nominee means the person named in the Schedule who has been nominated in accordance with Section 39 of the Insurance Act, 1938, as amended from time to time.
- Paid-up Sum Assured means the amount as calculated in accordance with Part D.
- 17. Paid-up Value means the value calculated in accordance with Part D.
- 18. Policy means the contract of insurance entered into between You and Us as evidenced by this Policy Document.
- 19. Policy Anniversary means the annual anniversary of the Policy Commencement Date.
- 20. Policy Commencement Date means the date on which the Policy commenced, as specified in the Schedule.
- 21. Policy Document means the arrangements established by this Policy and includes, the Proposal Form, the Schedule and any additional(s) statements or documents provided to Us by You in relation to the Proposal Form and any endorsements issued by Us.
- 22. Policy Term means the period in years between the Policy Commencement Date and the Maturity Date.
- 23. Policy Year means a period of twelve (12) months commencing on the Policy Commencement Date or any Policy Anniversary.
- 24. Premium Payment Term means the period specified in the Schedule during which Regular Premium is payable.
- 25. Proposal Form means the completed and dated proposal form submitted by the proposer to Us, including any declarations and statements annexed to it or submitted to Us in connection with the proposal for obtaining insurance cover under this Policy.
- 26. Regular Premium means the amount of the installment premium as specified in the Schedule (including any amount paid as extra premium, but excluding taxes, if any) payable by You during the Premium Payment Term, in the manner and at the intervals (premium frequency) as specified in the Schedule.
- 27. Revival Period means a period of two (2) years commencing from the date of the first unpaid Regular Premium.
- 28. Risk Commencement Date means the date on which the risk under this Policy commences, as specified in the Schedule.
- 29. Schedule means the schedule (including any annexure/tables attached to it and any endorsements) We have issued in connection with this Policy and, if more than one, then the latest in time.
- 30. Simple Reversionary Bonus means a bonus which may be declared by Us as a percentage of the Sum Assured after the end of every financial year based on Our experience, and which shall vest in the Policy, provided that all due Regular Premium till the date of accrual has been received.



- 31. Sum Assured means the amount specified in the Schedule.
- 32. Surrender Value means the amount payable, if any, on the surrender of the Policy in accordance with Part D.
- 33. Terminal Bonus means a bonus which may be declared by Us based on Our experience and which will be payable along with the Death Benefit or the Maturity Benefit or the Surrender Value, whichever becomes payable earliest.
- 34. We, Our or Us means the Aviva Life Insurance Company India Limited.
- 35. You or Your means the Policyholder named in the Schedule who has concluded this Policy with Us.

Where appropriate, references to the singular include references to the plural, references to a gender include the other gender and reference to any statutory enactment includes any amendment to that enactment and reference to days means calendar days only.

#### **Policy Benefits**

# 1. Maturity Benefit:

If the Insured is alive on the Maturity Date and provided all due Regular Premiums have been received by Us, in full, We shall pay:

- 1.1 The Maturity Sum Assured which is equal to the total Regular Premiums received by Us (excluding any amount received as extra premium); and
- 1.2 The vested Simple Reversionary Bonuses and Terminal Bonus (if any).

#### 2. Death Benefit:

- 2.1 If the Insured Event occurs during the Policy Term and provided that all due Regular Premiums until the date of the Insured Event have been received by Us in full, We will pay the Claimant the Death Sum Assured, which will be the highest of the following amounts:
  - 2.1.1 Ten (10) times of the Annualised Premium received; or
  - 2.1.2 105% of the Regular Premiums received (excluding any amount received as extra premium); or
  - 2.1.3 The Sum Assured; or
  - 2.1.4 The Maturity Sum Assured
- 2.2 In addition to the Death Sum Assured, the vested Simple Reversionary Bonuses and Terminal Bonus, if any, shall also be paid to the Nominee.
- 2.3 We will deduct from the Death Sum Assured any outstanding Regular Premium that would have been payable for the Policy Year in which the Insured Event occurs.
- 2.4 The Policy shall immediately terminate on the occurrence of the Insured Event.

#### 1. Free Look

You have the right to review the terms and conditions of this Policy, within the free look period which is 15 days from the date of receipt of the Policy Document. If You disagree to any of the terms or conditions, You have the option to return the Policy stating the reasons for Your objection.

If You cancel the Policy during the free look period, We will refund the Regular Premium received (including taxes, if any), subject only to a deduction of the expenses incurred by Us on medical examination, if any, proportionate risk premium for the period on cover and stamp duty charges.

#### 2. Revival

- 2.1 If We do not receive the Regular Premium in full within the Grace Period the Policy shall lapse which can be revived by You by giving Us a written notice to revive the Policy before the expiry of the Revival Period. The written notice to revive the Policy must be accompanied by all due Regular Premiums (including applicable taxes) along with interest at the rate of 9% per annum compounded monthly. You shall also provide Us with all information and documentation that We request. You understand and agree that:
- 2.1.1 You shall pay the due Regular Premiums and taxes (as applicable) along with interest at the aforesaid rate and such revival fees as may be determined by Us.
- 2.1.2 The Insured shall submit to the medical examination or special tests specified by Us at Your cost.
- 2.1.3 The Insured shall submit proof of continued insurability to Our satisfaction per Our Board approved underwriting policy.
- 2.1.4 Even if You have submitted all the information and documentation sought by Us there is no obligation on Us to revive the Policy or to revive it on the same terms and the revival is subject to Our board approved underwriting policy, as applicable from time to time.
- 2.1.5 The revival of the Policy shall only be effective from the date on which We have issued a written endorsement confirming the revival of the Policy.

# 3. Surrender Value

- 3.1 If We have received all the due Regular Premium for at least the first two (2) Policy Years, the Policy may be surrendered by You by giving Us written notice requesting the same and We will pay a Surrender Value, which will be the higher of the Guaranteed Surrender Value (GSV) and the Special Surrender Value(SSV)which will be calculated as follows:
- 3.1.1 The Guaranteed Surrender Value shall be calculated as follows:

{(GSV Factor\* x Regular Premiums received (excluding extra premium, if any))+ (Surrender Value of vested Simple Reversionary Bonus(as calculated below))}

Surrender Value of vested Simple Reversionary Bonuses\*\* = GSV Factor for Simple Revisionary Bonus x Vested Amount of Simple Reversionary Bonus

3.1.2 The Special Surrender Value shall be calculated as follows:

Paid-up Value (as calculated below) X Special Surrender Value Factor

Paid-up Value = Total number of Regular Premiums (excluding any amount received as extra premium, if any) + vested Simple Reversionary Bonuses.

We will apply the Special Surrender Value Factors as decided by Us, from time to time after the prior approval of the IRDAI.

- 3.2 Before making a request for surrender, You may approach Our nearest branch office to obtain information on the applicable Surrender Value and/or applicable Special Surrender Value Factor in respect of the Policy.
- 3.3 Once a Policy has been surrendered it shall not be revived.

# 4 Payment of Regular Premium, Grace Period and Paid-Up Value

- 4.1 Regular Premium shall be paid by You to Us on every Policy Anniversary.
- 4.2 If We do not receive the Regular Premium in full on the due date then, We shall allow a Grace Period for you to pay the unpaid Regular Premium to Us. If the Insured Event occurs during this Grace Period, We will make payments in accordance with Article 1 of Part C(after deduction of the unpaid Regular Premium).
- 4.3 If We do not receive the due unpaid Regular Premium in full within the Grace Period, then:
- 4.3.1 If all the due Regular Premiums for the first two (2) Policy Years have not been received by Us in full, then:
- 4.3.1.1 This Policy shall immediately and automatically lapse without acquiring any Paid-up Value
- 4.3.1.2 If You do not revive the Policy within the Revival Period then the Policy shall automatically terminate after payment of 30% of the Regular Premium received excluding extra premium, if any,
- 4.3.1.3 If the Insured Event occurs during the revival period after the expiry of the Grace Period, We will pay the Nominee the 100% of Regular Premium received excluding extra premium, if any.
- 4.3.2 If the Regular Premium for at least the first two (2) Policy Years has been received by Us in full, then:



- 4.3.2.1 This Policy shall automatically become a Paid-up Policy after the expiry of the Grace Period.
- 4.3.2.2 No future Simple Reversionary Bonus(es) will accrue under a Paid-up Policy. All Simple Reversionary Bonus that have already vested under the Policy before the Policy became a Paid-up Policy shall only be considered for all future benefits payable under the Paid-up Policy.
- 4.3.2.3 Unless the Policy is subsequently revived:
  - a) If the Insured Event occurs during the Policy Term when the Policy is a Paid-up Policy, We will pay the Nominee the Paid-up Sum Assured (as calculated below) along with the vested Simple Reversionary Bonuses and Terminal Bonus, if any. The Policy shall automatically terminate on the occurrence of the Insured Event.

Paid-up Sum Assured = Sum Assured x Total number of Regular Premiums received/Total number of Regular Premiums payable under the Policy

b) If the Insured is alive on the Maturity Date and the Policy is a Paid-up Policy as on the Maturity Date, We will pay the Paid-Up Value (as calculated below) along with the Terminal Bonus, if any. The Policy shall terminate on the Maturity Date.

Paid-up Value = Total number of Regular Premiums (excluding any amount received as extra premium) + vested Simple Reversionary Bonuses.

4.3.2.4 The Policy may be surrendered for the Surrender Value.

#### **General Terms & Conditions**

## 1. Agent's Authority

- 1.1. The insurance agent is only authorised by Us to arrange the completion and submission of the Proposal Form.
- 1.2. No insurance agent is authorised to amend the Policy or to accept any notice on Our behalf or to accept payments on Our behalf. If any payment meant for Us in any form is paid to an insurance agent then such payment is made at Your risk and the agent will be acting only as Your representative.

#### 2. Claim Procedure

Upon the death of the Insured during the Policy Term the death claim will be payable to the Claimant provided that:

- 2.1. We are given written notice within ninety (90) days of the occurrence of the death of the Insured during the Policy Term. If We are not given a written notice of the claim within ninety (90) days of the occurrence of the Insured Event, We may condone the delay beyond ninety days and accept the claim if We are given reasons in writing for the delay which in Our view are reasonable.
- 2.2. Upon the death of the Insured during the Policy Term the Claimant should contact us along with the following documents in order to enable Us establish the fact of, date of, circumstances relating to and cause of the Insured's death and/or Our liability in respect of it, including but not limited to:
  - 2.2.1. Original or certified copy of the death certificate issued by the municipal authorities.
    - 2.2.2. Original Policy Document.
    - 2.2.3. Our claim form duly completed, signed by the claimant and attested by the authorities as mentioned in the claim form.
- 2.2.4. Certified proof of cause of death of the Insured from a Medical Practitioner.
- 2.2.5. Last medical attendant/ Medical Practitioner's report, if applicable.
- 2.2.6. Employer's questionnaire, if applicable.
- 2.2.7. Medical records related to admission to a hospital/medical facility or consultation with a Medical Practitioner within the last three (3) years.
- 2.2.8. Identification proof of the Nominee and Appointee (if applicable) issued by a governmental authority.



- 2.2.9. Documentary proof, which establishes the Nominee and Appointee's relationship with the Insured.
- 2.2.10. Address proof of the claimant for the address mentioned in the claim form.
- 2.2.11. If the death of the Insured was caused due to un-natural or non- medical reasons, in addition to the above documents the following additional documents also need to be submitted to Us:
  - 2.2.11.1. Certified copies of First Information Report (FIR), Post Mortem Report (PMR), Final Police Inquest Report (FPIR).
  - 2.2.11.2. Newspaper articles/ cutting, if any.
- 2.3. For payment of the Maturity Benefit and/or Survival Benefits (if applicable under the Policy), We are given such information and/ or documentation that We may request in order to establish the fact of Our liability in respect of it, including but not limited to:
  - 2.3.1. Original Policy Document.
  - 2.3.2. Payout form duly filled in by You and/or the assignee, if any.
  - 2.3.3. Your and/or the assignee's (if any) identification proof issued by a governmental authority.
  - 2.3.4. Your and/or the assignee's (if any) address proof.
  - 2.3.5. Cancelled cheque for National Electronic Funds Transfer (NEFT) payment issued by You and/or the assignee (if any).
  - 2.4. We receive all co-operation and assistance in any investigation that We may decide to carry out in respect of the event giving rise to a claim under the Policy and/or any other benefits payable under the Policy.
  - 2.5. We may agree to accept minimum required documents on a case to case basis. In case due to any unnatural or other circumstances which are beyond Claimant's control, if the Claimant is unable to supply any of the above documents, then We may waive requirement of such documents provided We are totally satisfied with the investigation carried out to assess validity of the claim. We are entitled to ask for additional documents (including Policy document) or information for the processing of the claim. We may also seek professional/independent assistance for speedy disposal of the claim. You and/or the Nominee/legal heir shall have no objection for Us to obtain any details/information to form an opinion about the claim.

#### 3. Due Observance

The due observance of and compliance with the terms, provisions and conditions of the Policy insofar as they relate to anything to be done or complied with by You/Nominee shall be a condition precedent to Our liability under this Policy.



#### 4. Entire Contract

This Policy constitutes the entire contract of insurance between You and Us. We may amend the Policy if We consider this to be either necessary or desirable (to be evidenced by and effective from the date of an endorsement on the Schedule or otherwise) but agree not to do so without first having obtained the consent of the IRDA of India.

# 5. Governing Law

This Policy shall be governed by Indian laws. Any disputes or differences arising out of or under this Policy shall be governed by and determined in accordance with Indian law and shall be subject to the jurisdiction of Indian Courts.

# 6. Grace Period and Death during Grace Period

If the death of the Insured occurs within the Grace Period, the Death Benefit shall be payable after deducting the applicable due Regular Premium from the Death Benefit amount payable.

#### 7. Loss of the Policy

- 7.1. We will replace a lost Policy Document when satisfied that it is lost. However, We reserve the right to make such investigations into and/or to call for such evidence of the loss of the Policy Document at Your expense, as We consider necessary before issuing a duplicate Policy Document. We reserve the right to charge a fee not exceeding INR Two Hundred and Fifty for the issuance of a duplicate Policy Document.
- 7.2. If We agree to issue a duplicate Policy Document, it is hereby understood and agreed that the original Policy Document shall cease to be of any legal effect and You shall indemnify and keep Us indemnified and hold Us harmless from and against any claims, costs, expenses, awards or judgments arising out of or howsoever connected with the original Policy Document or arising out of the issuance of a duplicate Policy Document.
- 8. Fraud, Misrepresentation and forfeiture would be dealt with in accordance with provisions of section 45 of the Insurance Act 1938 as amended from time to time.

9. Nomination should be in accordance with provisions of section 39 of the Insurance Act 1938 as amended from time to time.

10. Assignment should be in accordance with provisions of section 38 of the Insurance Act 1938 as amended from time to time.

# 11. Notices & Correspondence

- 11.1. You shall give Us all notices, instructions and correspondence in writing at Our address specified in the Schedule or at any of Our branch offices.
- 11.2. All notices and correspondence meant for You will be in writing and will be sent by Us to Your address shown in the Schedule through speed post or courier or any other legally recognized mode of posting. Any change of Your address or Your Nominee's address must be notified to Us, failing which the notices and correspondence will be sent to the last recorded address and hence, We will not take any responsibility of any loss/damage owing to this.
- 11.3. Any Policy or any other communication shall be sent to You by Us through speed post or courier or any other legally recognized mode of posting, at the address provided in the Schedule.

#### 12. Suicide

If the Insured Event occurs due to suicide within twelve (12) months:

- 12.1. from the commencement of the Policy, We shall not be liable to make any payment under the Policy other than the refund of eighty (80%) of the Regular Premiums received (excluding extra premium if any) and provided all Regular Premiums due have been received till the date of occurrence of the Insured Event
- 12.2. from the date of revival of the Policy and provided all Regular Premiums due have been received till the date of occurrence of the Insured Event, We shall not be liable to make any payment under the Policy other than the refund of the higher of:
  - 12.2.1. eighty percent (80%) of the Regular Premiums received (excluding extra premium, if any); or
  - 12.2.2. Surrender Value (guaranteed surrender value or special surrender value, whichever is higher) as on the date of the Insured Event.

#### 13. Taxation

- 13.1. We shall deduct or charge any taxes or levies (including service tax), as applicable from time to time, from and/or on the premium payable or fee/charge payable or benefits payable/receivable under the Policy. We shall not be liable for any tax liability on Your and/or Nominee's income. You and/or the Nominee shall be solely responsible to assess, claim and/or ensure admissibility, or otherwise, of deductions under the tax laws in respect of the amount contributed or accrued/received. We do not hold any responsibility for Your and/or Nominee's claim to any deduction/s under the tax laws in respect of the amount contributed or accrued/received.
- 13.2. Tax laws are subject to amendments from time to time and We are not responsible to inform You and/or the Nominee of any changes in tax laws.



# 14. Termination

This Policy will immediately terminate on the earliest of:

- 14.1. The occurrence of the Insured Event and payment of a bonafide claim.
- 14.2. The Maturity Date.
- 14.3. On the surrender of the Policy.
- 14.4. On the expiry of the Revival Period, if the lapsed Policy is not reinstated.

# 15. Repudiation of Claim

The Policy shall terminate upon the repudiation of any false claim after proper investigation conducted by Us, if any.

# 16. Territorial Limits & Currency

All premium, taxes, levies and benefits are payable only within India and in Indian Rupees.

#### Annex 1

# Section 45 – Policy shall not be called in question on the ground of mis-statement after three years

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended by Insurance Laws (Amendment) Act 2015 which is deemed to have come into force on the 26<sup>th</sup> day of December 2014 are as follows:

- 01. No Policy of Life Insurance shall be called in question on any ground whatsoever after expiry of 3 yrs from
  - a. the date of issuance of policy or
  - b. the date of commencement of risk or
  - c. the date of revival of policy or
  - d. the date of rider to the policy whichever is later.
- 02. On the ground of fraud, a policy of Life Insurance may be called in question withi 3 years from
  - a. the date of issuance of policy or
  - b. the date of commencement of risk or
  - c. the date of revival of policy or
  - d. the date of rider to the policy whichever is later.


For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

- 03. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:
  - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
  - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
  - c. Any other act fitted to deceive; and
  - d. Any such act or omission as the law specifically declares to be fraudulent.
- 04. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.
- 05. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.



- 06. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.
- 07. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from date of repudiation.
- 08. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.
- 09. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.

Annex 2

## Section 39 - Nomination by policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act 2015 which is deemed to have come into force on the 26<sup>th</sup> day of December 2014. The extant provisions in this regard are as follows:

- 01. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.
- 02. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.
- 03. Nomination can be made at any time before the maturity of the policy.
- 04. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.
- 05. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.
- 06. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.
- 07. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
- 08. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.
- 09. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.
- 10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.
- 11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.
- 12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).



- 13. Where the policyholder whose life is insured nominates his
  - a. parents or
  - b. spouse or
  - c. children or
  - d. spouse and children
  - e. or any of them

the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.

- 14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).
- 15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Act, 2015 which is deemed to have come into force on the 26<sup>th</sup> day of December 2014.
- 16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.
- 17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Laws (Amendment) Act, 2015 which is deemed to have come into force on the 26<sup>th</sup> day of December 2014, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

Annex 3

# Section 38 - Assignment and Transfer of Insurance Policies

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act 2015 which is deemed to have come into force on the 26<sup>th</sup> day of December 2014. The extant provisions in this regard are as follows:

- 01. This policy may be transferred/assigned, wholly or in part, with or without consideration.
- 02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.
- 03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
- 04. The assignment must be signed by the transferor or assignor or duly authorize agent and attested by at least one witness.
- 05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
- 06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
- 07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
- 08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.
- 09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
  - a. not bonafide or
  - b. not in the interest of the policyholder or
  - c. not in public interest or
  - d. is for the purpose of trading of the insurance policy.
- 10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.
- 11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.



- 12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
- 13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
  - a. where assignment or transfer is subject to terms and conditions of transfer or assignment or
  - b. where the transfer or assignment is made upon condition that
    - i the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR
    - ii the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

- 14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
  - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
  - b. may institute any proceedings in relation to the policy
  - c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
- 15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Act, 2015 which is deemed to have come into force on the 26<sup>th</sup> day of December 2014 shall not be affected by this section.
