This is your policy booklet containing the various terms and conditions governing your policy. This policy booklet should be read in conjunction with the policy schedule and other related documents of your policy.

If you find any errors, please return the policy for effecting corrections.

1. Definitions

These definitions apply throughout your policy document.

The definitions are listed alphabetically. Items marked with † alongside are mentioned in your policy schedule.

Expressions	Meanings
1. Accumulated Value of Discontinued Policy Fund	is the fund value of the discontinued policy fund. This fund will earn a minimum guaranteed return of 4% per annum. This rate may change as per the relevant Regulations as amended from time to time.
2. Age	is the age last Birthday i.e. the age in completed years.
3. Age at Entry †	is the age last Birthday on the Date of Commencement of Policy.
4. Allocation Charge or Premium Allocation Charge	is the percentage of Premium that would not be utilised to purchase units.
5. Allocation Percentage	is the percentage of Premium that will be invested in the chosen Plan option at inception. The percentages will be as per the Plan option under Automatic Asset Allocation Plan (AAA Plan).
6. Annualised Premium	is the total amount of Premium payable in a Policy Year.
7. Applicable Partial Withdrawal (APW)	is equal to partial withdrawals made, if any, during the last 2 years immediately preceding the death of the Life assured if the age of the life assured at death is less than 60 years of age
8. Appointee †	is the person who is so named in the proposal form or subsequently changed by an Endorsement, who has the right to give a valid discharge to the policy monies in case of the death of the Life Assured during the term of the policy while the Nominee is a Minor.
9. Assignee	the person to whom the rights and benefits are transferred by virtue of an assignment under section 38 of the Insurance Act, 1938, as amended from time to time.
10. Birthday	is the conventional Birthday. If it is on 29 th February, it will be considered as falling on the last day of February.
11. Business Day	is our working day.
12. Complete Withdrawal	is same as surrender.
13. Date of Allocation	is the date on which the Premium is invested in the funds.
14. Date of Commencement of Policy †	is the start date of the policy.
15. Date of Commencement of Risk †	is the date from which the insurance cover under the policy commences
16. Date of Discontinuance	is the date on which we receive a communication from you requesting for surrender of the policy or discontinuance of the policy or on the date of expiry of notice period within which you are supposed to exercise an option as per the options given in the notice of discontinuance, whichever is earlier.
17. Date of Maturity †	is the date on which the term of the policy expires in case the policy is not terminated earlier.
18. Date of Revival	is the date on which the policy benefits are restored at the conclusion of the

	revival process.
19. Date of Surrender	is the date on which we receive a communication from you requesting for surrender of the policy with all the necessary requirements. In case the requirements are not received in full, the date of surrender will be the date on which the last requirement for surrender of policy is received.
20. Death Benefit	is the amount payable on death of the Life Assured.
21. Discontinuance	is the state of the policy that could arise on account of surrender of the policy or non-payment of renewal premium, if any, before the expiry of the Discontinuance Notice Period. If after the lock in period, the policyholder opts to revive the policy within a period of two years, the policy will be deemed not to be in a state of discontinuance.
22. Discontinuance Charge	- is a charge levied when a policy is Discontinued or Surrendered. - is either - a percentage of one Annualised Premium or Single Premium or - a percentage of Fund Value as on the Date of Discontinuance / surrender or - a fixed amount., as the case may be
23. Discontinuance Notice	is a notice we will send you within a period of 15 days from the date of expiry of Grace Period in case we do not receive your due Premium. Non-receipt of notice of discontinuance shall not be construed as a breach of contractual obligations on the part of the Company
24. Discontinuance Notice Period/ Notice Period	is a period of 30 days after you receive the Discontinuance Notice
25. Discontinued Policy Fund	is the segregated fund we set aside and is constituted by the Fund Value of Discontinued policies after deduction of applicable Discontinuance Charge.
26. Endorsement	is a change in any of the terms and conditions of the policy, agreed to or issued by us, in writing.
27. Financial Year	is the period commencing from 1 st April of any year to 31 st March of the following year.
28. First Year Premium	is the total of premiums due and payable in first Policy Year.
29. Free-look Period	is the period during which the Policyholder has the option to return the policy and cancel the contract.
30. Fund Management Charge	is the deduction made from the fund at a stated percentage before the computation of the NAV of the fund.
31. Fund Value	is the product of the total number of units under the funds and the corresponding NAVs.
32. Grace Period	is the period beyond the premium due date when the policy is treated as In-force but the policyholder is still liable to pay the outstanding premium.
33. In-force	is the status of the policy when all the due premiums have been paid or the policy is not in a state of Discontinuance.
34. Installment Premium [†] / Premium	is the contractual amount payable by you on each Premium Due Date in order to secure the benefits under the provisions of your policy.
35. Instrument	cheque, demand draft, pay order etc.
36. Insurance Cover	means coverage for Insured Event. On occurrence of the insured event, the contingent benefits are payable to the Policyholder or Nominee or legal heir, as the case may be, and the insurance cover will cease thereafter.
37. Legal Heir	means the person(s) legally eligible to receive the insurance benefits under the provisions of the policy in case the Nominee is not surviving or the nomination is invalid.
38. Life Assured [†]	is the person in relation to whose life, insurance and other benefits are granted under the policy.
39. Lock-in Period	is a period of five consecutive years starting from date of commencement of policy during which Discontinuance / Surrender Value is not payable, except

	in the case of death or upon happening of any other contingency covered under the policy.
40. Maturity Benefit	is the benefit payable on maturity of the policy.
41. Mortality Charges	are the charges recovered for providing life insurance cover.
42. Nominee †	is the person who is named as the Nominee in the proposal form or subsequently changed by Endorsement, as per Section 39 of the Insurance Act, 1938, as amended from time to time, who has the right to give a valid discharge to the policy monies in case of the death of the Life Assured, during the term of the policy, if such nomination is not disputed.
43. Non-participating	means the policy does not have a share in our profits.
44. Our, Us, We †	SBI Life Insurance Company Limited or its successors. We are regulated by the Insurance Regulatory and Development Authority of India (IRDAI). The registration number allotted by the IRDAI is 111.
45. Paid-up	is the status of policy opted by you in which no further premiums are payable and the insurance cover continues for a reduced sum assured called as Paid-up sum assured. During the paid-up period, all applicable charges would be deducted.
46. Paid-up sum assured	is equal to the sum assured multiplied by the ratio of total number of premiums paid to the original number of premiums payable as per the terms and conditions of the policy.
47. Policy Administration Charge/fee	is a charge recovered towards administrative expenses of the policy. This charge is applied at the beginning of each policy month by cancelling units for equivalent amount.
48. Policy Anniversary	is the same date each year during the Policy Term as the Date of Commencement of Policy. If the Date of Commencement of Policy is on 29 th of February, the Policy Anniversary will be taken as the last date of February.
49. Policy Document	means the policy schedule, policy booklet, endorsements (if any), rider documents (if any). Any subsequent written agreements (if any) mutually agreed by you and us during the term of the policy also form a part of the Policy document. It consists of Part A,B,C,D,E,F and G and subsequent endorsements, if any, after the issue of the policy.
50. Policy Month	is the period from the Date of Commencement of Policy, to the date prior to the corresponding date in the following calendar month or similar periods thereafter beginning from the dates in any calendar month corresponding to the Date of Commencement of policy. If the said corresponding date is not available in a calendar month, then the last day of the calendar month will be taken for this purpose.
51. Policy Schedule	is the document that sets out the details of your policy.
52. Policy Term †	is the period commencing with the Date of commencement of the Policy and terminating with the Date of maturity,
53. Policy Year	is the period between two consecutive Policy Anniversaries. This period includes the first day of the Policy year and excludes the next policy anniversary day.
54. Policyholder †	is the owner of the policy and is referred to as the proposer in the proposal form. The Policy owner need not necessarily be the same person as the Life Assured.
55. Premium Frequency †	is the period between two consecutive premium due dates for regular premium policy; the premium frequency can be either of Yearly or Monthly.
56. Premium Paying Term †	is the period, in years, over which premiums are payable.
57. Regular Premium	is the Installment Premium payable over the Premium Paying Term at the chosen Premium Frequency.

58. Premium Due Date †	is the date on which premiums are payable under the policy, during the Premium Paying Term. If the said corresponding date is not available in a calendar month, then the last day of the calendar month will be considered for this purpose.
59. Revival	is the process of restoring the benefits under the policy which are otherwise in the state of discontinuance due to non-payment of premiums on due dates.
60. Revival Period	is a period of two years from the date of discontinuance.
61. Settlement installment	is the amount of each installment receivable during the Settlement Period
62. Settlement Option	is the option to receive the maturity benefits spread over a chosen period
63. Settlement Period	is the chosen period over which the maturity benefit is payable on exercising of the Settlement Option
64. Settlement Year	Is the one year period during the Settlement Period, starting from Date of Maturity
65. Sum Assured Multiplier Factor (SAMF) †	is the multiple applied on the Annualized Premium to arrive at the Basic Sum Assured.
66. Sum Assured †	is the amount of insurance cover guaranteed under the Policy at the time of the inception of policy.
67. Surrender	is the voluntary termination of the contract by the Policyholder before the expiry of the policy term.
68. Surrender Value	is the amount of benefit payable to the Policyholder on Surrender of the policy.
69. Survival Benefit	is the benefit that depends on survival of the Life Assured at specified intervals.
70. Term †	is same as "Policy Term".
71. Underwriting	- is the process of classification of lives into appropriate homogeneous groups based on the risks covered. - based on underwriting, a decision is taken as to whether a risk cover can be granted and if so at what rates of premium and under what terms.
72. Unit-linked	in a Unit-linked policy, the value of units in Chosen Funds will vary based on market price of the underlying assets and the investment risk is borne by the Policyholder.
73. Units	are identical subset of the funds' assets and liabilities as the fund is divided into a number of equal units.
74. Valuation Date	is the Date of calculation of NAV.
75. You, Your †	is the person named as the Policyholder.

The above definitions are provided only for the purpose of proper comprehension of the terms & phrases used in the policy document. The actual benefits under the policy are payable strictly as per the terms and conditions of the policy only.

3. Base Policy Benefits**3.1. Death Benefit**

In case of death of the life assured, we will pay the following death benefits:

- 3.1.1 In case the death intimation is received while the policy is in-force, we will pay the highest of the following:
 - 3.1.1.1 Your Fund Value as on the date of death intimation or
 - 3.1.1.2 Sum Assured less Applicable Partial Withdrawals (APW) or
 - 3.1.1.3 105% of the total Premiums paid till date of intimation of death
- 3.2.1 In case of death of the life assured while policy is in paid-up status, we will pay the highest of the following:
 - 3.2.1.1 Your Fund Value as on the date of death intimation or
 - 3.2.1.2 Paid-up Sum Assured less Applicable Partial Withdrawals (APW)
- 3.3.1 In case death intimation is received after the Date of Discontinuance,
 - 3.3.1.1 If death has occurred on or before the Date of Discontinuance, we will pay
 - 3.3.1.1.1 Same death benefit as stated in 3.1.1.
 - 3.3.1.2 If death has occurred after the Date of Discontinuance, we will pay
 - 3.3.1.2.1 Accumulated Fund Value of your Discontinued Policy Fund at the time of intimation of death to the company.

3.2. Maturity Benefit

We will pay your Fund Value as Maturity benefit.

- 3.2.1. You can choose to receive your maturity benefit by exercising one of the following two options:
 - 3.2.1.1. A lump-sum amount of your Fund Value as on the Date of Maturity or
 - 3.2.1.2. Amounts payable as per the Settlement Option (to receive the maturity value in instalments)
- 3.2.2. In case we do not receive your option within the stipulated period, the Maturity value will be paid in lump-sum, by default.

4. Premiums

- 4.1 You are required to pay the Premiums in full always on or before the Premium due dates. Payment of premium before premium due date would be allowed, only within the same financial year.
- 4.2 You are required to pay unpaid Premium, if any, on or before expiry of Discontinuance Notice Period.
- 4.3 If we receive any Premium in advance, units will be allocated only on the Premium due date. We will not pay any interest on Premium received in advance.
- 4.4 You are required to pay the Premiums even if you do not receive Premium notice or any other communication from us.
- 4.5 You will be liable to pay all applicable taxes as levied by the Government and other Statutory Authorities.
- 4.6 If we receive any amount in excess of the required Premium, we will refund the excess premium without any interest.
- 4.7 If we receive any amount less than the Required Premium, we will not adjust the amount towards premium till you pay the balance of premium. We will not pay any interest on the partial premium paid by you.

5. Grace Period

- 5.1 Grace Period for this plan is 30 days for Annual premium payment frequency and 15 days for Monthly premium payment frequency.
- 5.2 Your policy will be treated as in-force during the grace period.

6. Settlement Option

- 6.1 You should write to us at least 60 days and not before 365 days prior to the Date of Maturity, to exercise this option. We will then pay the maturity benefit in installments.

- 6.8.4 We will pay you the installments only through ECS if you have chosen Half-yearly, Quarterly or Monthly frequency for payment.
- 6.8.5 For payment, we will redeem appropriate number of units from each fund based on the percentage of that fund to the total Fund Value as on the date of payment
- 6.8.6 You can ask for full payment of remaining Fund Value at any time
- 6.8.7 We will not deduct any charges except FMC
- 6.8.8 We will not allow any partial withdrawal
- 6.8.9 We will not allow any switching between funds
- 6.8.10 In case of death of the Policyholder, we will pay the then available Fund Value

7. Surrender

- 7.2 In case we receive your Surrender request after the expiry of the Lock-in Period,
- 7.2.1 We will disinvest your units in all funds
- 7.2.2 We will pay you the Surrender Value immediately
- 7.2.3 Surrender Value is your Fund Value.
- 7.3 All the rights and benefits under the policy will automatically come to an end on surrender of your policy.
- 7.4 Lock-in period is 5 years from the date of commencement of the Policy.

8. Partial Withdrawal

You can withdraw your fund partially during the policy term. Such withdrawals will be subject to all of the following:

- 8.1 You can withdraw from the 6th Policy Year, subject to payment of all the due premiums for the first five policy years.

9. Discontinuance of Premium

- 9.1 If you have not paid any premium due within the Grace Period, we will send you the Discontinuance Notice within 15 days from the expiry of Grace Period. Non-receipt of the discontinuance notice however, will not be construed as a breach of any contractual obligation on our part.

- 9.8 **If you opt to completely withdraw from the policy during the notice period or do not exercise any of the options during notice period, then:**
 - 9.8.1 **If premium is discontinued during first five policy years**
 - 9.8.1.1 Your fund value as on the date of receipt of your option or the last day of the discontinuance notice period if no option is exercised, as the case may be, will be disinvested and credited to Discontinued Policy Fund net of applicable discontinuance charge.

18.5 Extraordinary Circumstances

However, we reserve the right to change the exposure of all/any Fund to money market instruments to 100% only in extreme situations external to the company, keeping in view market conditions, political situations, economic situations, war/war-like situations, terror situations. the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectus or tables of the insurer:

Provided that acceptance by an insurance agent of commission in connection with a policy of life insurance taken out by himself on his own life shall not be deemed to be acceptance of a rebate of premium within the meaning of this sub-section if at the time of such acceptance the insurance agent satisfies the prescribed conditions establishing that he is a bona fide insurance agent employed by the insurer.

(2) Any person making default in complying with the provisions of this section shall be liable for a penalty which may extend to ten lakh rupees.

22.4 Provision 12 (1) of Redressal of Public Grievances Rules, 1998

The Ombudsman may receive and consider

- (a) Complaints under Rule 13
- (b) Any partial or total repudiation of claims by an insurer
- (c) Any dispute in regard to premium paid or payable in terms of the policy
- (d) Any dispute on the legal construction of the policy, insofar as such disputes relate to claims
- (e) Delay in settlement of claims
- (f) Non-issue of any insurance document to customers after receipt of premium

22.5 Provision 13 of Redressal of Public Grievances Rules, 1998

- (1) any person who has a grievance against an insurer, may himself or through his legal heirs make a complaint in writing to the Ombudsman within whose jurisdiction the branch or office of the insurer complained against is located.
 - (2) the complaint shall be in writing duly signed by the complainant or through his legal heirs and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against which the complaint is made, the fact giving rise to complaint supported by documents, if any, relied on by the complainant, the nature and extent of the loss caused to the complainant and the relief sought from the Ombudsman.
 - (3) no complaint to the Ombudsman shall lie unless –
 - (a) the complainants had before making a complaint to the Ombudsman made a written representation to the insurer named in the complaint and either insurer had rejected the complaint or the complainant had not received any reply within a period of one month after the insurer concerned received his representation or the complainant is not satisfied with the reply given to him by the insurer.
 - (b) the complaint is made not later than one year after the insurer had rejected the representation or sent his final reply on the representation of the complainant, and
 - (c) the complaint is not on the same subject matter, for which any proceedings before any Court, or Consumer Forum or Arbitrator is pending or were so earlier.

Annexure I

Section 38 - Assignment and Transfer of Insurance Policies

Assignment or transfer of a policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act, 2015 dated 23.03.2015. The extant provisions in this regard are as follows:

01. This policy may be transferred/assigned, wholly or in part, with or without consideration.

02. An Assignment may be effected in a policy by an endorsement upon the policy itself or by a separate instrument under notice to the Insurer.

03. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.

04. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.

05. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.

06. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.

07. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.

08. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the policy is being serviced.

09. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
 - a. not bonafide or
 - b. not in the interest of the policyholder or
 - c. not in public interest or
 - d. is for the purpose of trading of the insurance policy.

10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of policyholder giving a notice of transfer or assignment.

11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.

12. The priority of claims of persons interested in an insurance policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the

priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.

13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except

a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR

b. where the transfer or assignment is made upon condition that

i. the proceeds under the policy shall become payable to policyholder or nominee(s) in the event of assignee or transferee dying before the insured OR

ii. the insured surviving the term of the policy

Such conditional assignee will not be entitled to obtain a loan on policy or surrender the policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person

a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and

b. may institute any proceedings in relation to the policy

c. obtain loan under the policy or surrender the policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings

15. Any rights and remedies of an assignee or transferee of a life insurance policy under an assignment or transfer effected before commencement of the Insurance Laws (Amendment) Act, 2015 shall not be affected by this section.

Annexure II

Section 39 - Nomination by policyholder

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended by Insurance Laws (Amendment) Act, 2015 dated 23.03.2015. The extant provisions in this regard are as follows:

01. The policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the policy shall be paid in the event of his death.

02. Where the nominee is a minor, the policyholder may appoint any person to receive the money secured by the policy in the event of policyholder's death during the minority of the nominee. The manner of appointment to be laid down by the insurer.

03. Nomination can be made at any time before the maturity of the policy.

04. Nomination may be incorporated in the text of the policy itself or may be endorsed on the policy communicated to the insurer and can be registered by the insurer in the records relating to the policy.

05. Nomination can be cancelled or changed at any time before policy matures, by an endorsement or a further endorsement or a will as the case may be.

06. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the policy or in the registered records of the insurer.

07. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.

08. On receipt of notice with fee, the insurer should grant a written acknowledgement to the policyholder of having registered a nomination or cancellation or change thereof.

09. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the policy. The nomination will get revived on repayment of the loan.

10. The right of any creditor to be paid out of the proceeds of any policy of life insurance shall not be affected by the nomination.

11. In case of nomination by policyholder whose life is insured, if the nominees die before the policyholder, the proceeds are payable to policyholder or his heirs or legal representatives or holder of succession certificate.

12. In case nominee(s) survive the person whose life is insured, the amount secured by the policy shall be paid to such survivor(s).

13. Where the policyholder whose life is insured nominates his
- a. parents or
 - b. spouse or
 - c. children or
 - d. spouse and children
 - e. or any of them

the nominees are beneficially entitled to the amount payable by the insurer to the policyholder unless it is proved that policyholder could not have conferred such beneficial title on the nominee having regard to the nature of his title.

14. If nominee(s) die after the policyholder but before his share of the amount secured under the policy is paid, the share of the expired nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such nominee(s).

15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after the commencement of Insurance Laws (Amendment) Act, 2015.

16. If policyholder dies after maturity but the proceeds and benefit of the policy has not been paid to him because of his death, his nominee(s) shall be entitled to the proceeds and benefit of the policy.

17. The provisions of Section 39 are not applicable to any life insurance policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where before or after Insurance Laws (Amendment) Act, 2015, a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the policy. In such a case only, the provisions of Section 39 will not apply.

Annexure III

Section 45 – Policy shall not be called in question on the ground of mis-statement after three years

Provisions regarding policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended by Insurance Laws (Amendment) Act, 2015 dated 23.03.2015 are as follows:

01. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 yrs from

- a. the date of issuance of policy or
- b. the date of commencement of risk or
- c. the date of revival of policy or
- d. the date of rider to the policy

whichever is later.

02. On the ground of fraud, a policy of Life Insurance may be called in question within 3 years from

- a. the date of issuance of policy or
- b. the date of commencement of risk or
- c. the date of revival of policy or
- d. the date of rider to the policy

whichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

03. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance policy:

- a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
- b. The active concealment of a fact by the insured having knowledge or belief of the fact;
- c. Any other act fitted to deceive; and
- d. Any such act or omission as the law specifically declares to be fraudulent.

04. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak or silence is in itself equivalent to speak.

05. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or

suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the policyholder, if alive, or beneficiaries.

06. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the policy of life insurance is based.

07. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on policy till the date of repudiation shall be paid to the insured or legal representative or nominee or assignees of insured, within a period of 90 days from the date of repudiation.

08. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance policy would have been issued to the insured.

09. The insurer can call for proof of age at any time if he is entitled to do so and no policy shall be deemed to be called in question merely because the terms of the policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
