

Reliance Hotel & Restaurant Package Policy Prospectus

Introduction

The specially designed Package Policy for Hotels & Restaurants provides cover to the Proposer under the following respective sections:

- I. Building / Contents (Excluding Money and Valuables)
- II. Alternate Accommodation
- III. Business Interruption (Fire)
- IV. Electronic Equipment
- V. Reinstatement of Data
- VI. All Risk Cover Portable Electronic Equipment
- VII. Machinery Breakdown
- VIII. Burglary And Housebreaking Contents (Excluding Money and Valuables)
- IX. Money Insurance
- X. Fixed Plate Glass
- XI. Neon Sign / Glow Sign / Hoarding
- XII. Accompanied Baggage
- XIII. Personal Accident
- XIV. Fidelity of Employees
- XV. Liability
- XVI. Workmen Compensation
- XVII. Loss of Liquor Licence
- XVIII. Loss of Accounts Receivable

Scope of Covers

Section I - Building / Contents (Excluding Money and Valuables)

This Section covers building/s (i.e. the structure wherein the Proposer's Hotel or Restaurant is situated), machinery, equipment, furniture, fixtures and fittings, electrical installations and stock and stock-in-trade against fire and allied perils.

The basis of valuation in respect of buildings and contents other than stock and stock-in-trade shall be on reinstatement value or market value, as opted by the Proposer. However, in respect of stock and stock-in-trade it shall be on market value. The facility of declaration of stocks will not be available. Under this Section the Company will indemnify the Proposer in respect of loss or of damage to the building, and/or contents, whilst contained in the insured Hotel or Restaurant by:

- a) Fire.
- b) Lightning.
- c) Explosion and Implosion.
- d) Aircraft or articles dropped therefrom.
- e) Riot, strike and malicious act.
- (f) Flood, inundation, storm, tempest, typhoon, hurricane, tornado, or cyclone

(g) Impact damages: Loss of or visible physical damage or destruction caused to the property insured due to impact by any rail/road vehicle or animal by direct contact not belonging to or owned by

- the Proposer or any occupier of the premises or
- their employees while acting in the course of their employment.
- (h) Subsidence and Landslide including Rockslide
- (i) Bursting and/or overflowing of Water tanks, apparatus, and pipes.
- (j) Missile testing operations.
- (k) Leakage from automatic sprinkler installations.
- (I) Bush Fire.
- (m) Earthquake, fire and/or shock

Section II - Alternate Accommodation

If the Hotel or Restaurant is damaged due to fire and allied perils including earthquake for which a claim is admissible under Section I of the Policy then this section provides for payment of expenses of additional rent for alternative accommodation that the Proposer avails of during the Policy period. This benefit is subject to the Sum Insured selected by the Proposer.

Section III : Business Interruption (Fire)

This Section covers loss due to interruption or interference with the business carried on by the Proposer at the Hotel or Restaurant covered under Section I, in consequence of loss, destruction or damage indemnifiable under Section I subject to the Sum Insured.

Subject to the terms, provisions and exclusions of the Consequential Loss (Fire) Insurance the cover under this Section shall be limited to loss of Gross Profit due to (a) reduction in turnover and (b) increase in cost of working, and the amount payable as indemnity shall in respect of:

- (a) reduction in turnover be the sum produced by applying the rate of gross profit to the amount by which the turnover during the Indemnity Period falls short of the standard turnover in consequence of the loss, destruction or damage.
- (b) increase in cost of working, be the additional expense necessarily and reasonably incurred for the sole purpose of avoiding or diminishing the reduction in turnover (not exceeding the sum produced by applying the rate of gross profit to the amount of the reduction thereby avoided).

Section IV : Electronic Equipment

This Section indemnifies the Proposer against any unforeseen and sudden physical loss or damage to electronic equipment detailed in the Schedule, belonging to the Proposer from any cause, other than those specifically excluded.

This Section covers electronic appliances, apparatus, gadgets, electronic equipment and/or any electronic installation pertaining to Proposer's business while contained or fixed in the Proposer's Hotel or Restaurant.

The Sum Insured in respect of each item for coverage under this Section shall be equal to the cost of replacement of such item by a new item of the same kind and capacity which shall mean its current new replacement cost including ordinary freight, customs duty, other dues, if any, and cost of erection (CNRV basis).

Coverage under this Section is subject to an excess of 5% of the claim amount subject to a minimum of Rs.1, 000/- in respect of each and every claim for loss or damage admitted under the Policy.

Section V : Reinstatement of Data

This Section indemnifies the Proposer against the cost of reinstating data on data carrying materials and for programmes. In the event of damage to data contained in or on data carrying materials or to programmes, the benefit under this Section is subject to Sum Insured.

Section VI : All Risks – Portable Electronic Equipments

The Section indemnifies the Proposer against any unforeseen and sudden physical loss or damage from any cause other than those specifically excludes in the policy to portable electronic equipments specified in the Schedule and belonging to the Proposer and in the personal custody of the Proposer, director or employee whilst anywhere in India for the purpose of business.

The liability of the Company will be limited to Sum Insured against each item in Schedule and not exceeding in aggregate the total Sum Insured stated in Schedule in any one Period of Insurance.

Section Vil : Machinery Breakdown

This Section covers all electrical and/or mechanical appliances, apparatus, gadgets and/or any electrical or mechanical installation pertaining to the business while contained or fixed in the Proposer's Hotel or Restaurant against loss or damage due to unforseen and sudden accidental physical damage quised by and /or solely due to mechanical and/or electrical breakdown.

The Sum Insured in respect of each item for coverage under this Section shall be equal to the cost of replacement of such item by a new item of the same kind and capacity which shall mean its current new replacement cost including ordinary freight, customs duty, other dues, if any, and cost of erection (CNRV basis).

Basis of Indemnity

- (a) In cases where damage to an insured item can be repaired, the Company will pay expense necessarily incurred to restore the damaged machine to its former state of serviceability plus the cost of dismantling and re-erection incurred for the purpose of effecting the repairs as well as ordinary freight to and from a repair-shop, customs duties, if any, to the extent such expenses have been included in the Sum Insured.
- (b) In cases where an insured item is destroyed, the Company will pay the actual value of the item immediately before the occurrence of the loss including costs for ordinary freight, erection and customs duties, if any, provided such expenses, have been included in the Sum Insured, such actual value to be calculated by deducting proper depreciation from the replacement value of the item. The Company will also pay any normal charges for the dismantling of the machinery destroyed but the salvage will be taken into account.

Any extra charges incurred for over time, night-work, work on public holidays, express freight are covered by the insurance only if especially agreed to in writing.

Section VIII : Burglary & Housebreaking – Contents (Excluding Money and Valuables)

This Section covers

a) Contents being items of property in the Proposer's Hotel or Restaurant consisting of machinery, equipment, furniture, fixtures and fittings, electrical installations and stock and stock-in-trade including items of property for which the Proposer is accountable against burglary and housebreaking.

The basis of valuation in respect of contents other than stock and stock-in-trade shall be on reinstatement value or market value, as opted by the Proposer. However, in respect of stock and stock-in-trade it shall be on market value.

b) Damage to the Proposer's Hotel or Restaurant and/or safe resulting from burglary and/or housebreaking or any attempt thereat, subject to a maximum of 5 % of the Sum Insured under this Section.

Provided however that no loss under a) and b) hereinabove, shall together exceed the Sum Insured under this Section.

The terms Burglary and/or House breaking shall, for the purpose of Insurance and liability of the Company, mean

- a. Theft involving entry into or exit from the Proposer's Hotel or Restaurant by forcible and violent means or
- b. Theft following assault or violence or threat to the Proposer or any employee of the Proposer or member of the Proposer's family.

Coverage under this Section, shall not include larceny, loss due to acts of fraud or dishonesty of the employees, inventory shortage or unexplained disappearance.

This Section is on first loss basis.

Section IX : Money Insurance

This Section covers loss of money of the Hotel or Restaurant due to:

I. While in transit, between the Proposer's Hotel or Restaurant and Bank (including Automatic Teller Machine centers) and vice versa

- II. Burglary and/or Housebreaking, whilst contained in safe, burglar resistant or other steel cupboards/cashbox and/or such other places under lock and key in the Hotel or Restaurant.
- III. Burglary and/or Housebreaking whilst lying in the cashier's till in the Proposer's Hotel or Restaurant, during business hours consequent to or following assault and/or violence against the Proposer or any employee of the Proposer or any threat.

Section X : Fixed Plate Glass

This Section covers loss or damage due to accidental breakage in the Proposer's Hotel or Restaurant of

- a) Fixed plate glass and sanitary fittings,
- b) Frames or framework,
- c) Lettering consequent upon the breakage of glass.

The Sum Insured shall be on reinstatement value basis. Coverage under this Section is subject to an excess of 5% of the claim amount or Rs 500/- whichever is less, in respect of each and every claim for loss or damage admitted under the Policy.

Section XI : Neon Sign / Glow Sign /Hoarding

This Section covers Neon sign and/or Glow sign and/or Hoarding belonging to and fixed in the Proposer's Hotel or Restaurant against loss or damage due to accidental external means, fire, lightning, external explosion, theft of whole sign/hoarding, riot, strike and malicious damage and storm, tempest, flood and inundation, rain, hail, flood and bad weather.

The Sum Insured is based on reinstatement value for Neon sign and Glow sign and on market value for Hoarding. Coverage under this Section is subject to an excess of 5 % of the claim amount or Rs. 500/- whichever is less, in respect of each and every claim for loss or damage admitted under the Policy.

Section XII : Accompanied Baggage

This Section covers loss of baggage of proprietor, partner, principal officer and an employee who is in the permanent employ of the Proposer due to accident or misfortune during any journey undertaken in connection with their official duties outside the city, town or municipal limits of the place where the Proposer's Hotel or Restaurant is situated. Provided Always that no liability will arise for any claim which is otherwise indemnifiable by a contract of affreightment for accompanied or checked in baggage.

Baggage shall mean and include

- a) Goods for which the proprietor, partner, principal officer or an employee in the permanent employ of the Proposer is officially responsible to the Proposer, his/their personal articles and belongings necessary for undertaking the journey and articles or things acquired during the journey.
- b) Travelling advance not exceeding Rs 10,000/-.

This Section is subject to an excess of Rs 250/- in respect of each and every claim for loss or damage admitted under the policy.

Annexure !

Section XIII : Personal Accident

- 1. This Section provides for compensation to the Insured Person (i.e. proprietor, partner, director or an employee in permanent employ of the Proposer and between 18 and 70 years of age) towards bodily injury solely and directly caused by accidental, violent, external and visible means resulting in death or disablement within 12(twelve) calendar months of occurrence of such injury.
- 2. It also provides for reimbursement, in the event of the death of the Insured Person due to injury caused solely and directly by accidental, violent, external and visible means outside his/her residence, of the expenses incurred for transportation of Insured Person's dead body to the place of residence subject to a maximum of Rs 2,500/-.
- 3. It further provides for, in the event of death or permanent total disablement of the Insured Person caused solely and directly by accidental, violent, external and visible means, compensation towards Education Fund for dependent children as below:

provided that the age limit of 23 years shall apply as on date of accident and not at the beginning of the policy year.

4. Upon payment of additional premium of 20%, the Policy can be extended to cover medical expenses upto 40% of the compensation payable in settlement of a valid claim under the Policy or 20% of the relevant Sum Insured, whichever is less.

Subject to the Capital Sum Insured (CSI) being the maximum liability of the Company under this Section, the Company shall pay to the Insured the sum or sums as set forth in the Table of Benefits below:

If such injury shall be the sole and direct cause of temporary total disablement, then so long as the Insured Person shall be totally disabled from engaging in any employment or occupation of any description whatsoever, a sum at the rate of one percent (1%) of the Capital Sum Insured under this section hereto per week, but in any case not exceeding Rs. 5,000/- per week in all, under all policies.

Provided that compensation for temporary total disablement shall not be payable for more than 100 weeks in respect of any one injury calculated from the date of commencement of disablement and in no case shall exceed the Capital Sum Insured.

The Company will not be liable for compensation under more than one of the items (1) to (6) above, in the same period of disablement of the Insured Person.

Section XIV : Fidelity of Employees

This Section provides cover against direct pecuniary loss caused by dishonest acts / infidelity of employees to be specified in the Schedule. The Policy can be on named/unnamed basis. Where it is unnamed, it should be designation / position based. Where it is position based, all employees in that position are required to be covered.

Section XV : Liability

This Section covers Proposer's legal liability (other than liability under the Public Liability Insurance Act, 1991 or any amendments thereto or other statute based on the doctrine of liability or product or pollution liability) to pay compensation including claimant's costs, fees and expenses incurred anywhere in India, in accordance with Indian Law.

- Pollution howsoever caused,
- Any product.

The cover under this Section also includes the following:

(a) Valuables under Care, Control and Custody

(b) Food and Beverages

(c) Extra facilities such as health clubs, beauty parlours shops swimming pools, indoor and outdoor sports:

(d) Aqua Sports facilities

(e) For inclusion of Skydiving, Skiing and hang gliding

(f) Act of God Perils

(g) Pollution

- (in) Valet Parking
- (i) Lifts

Coverage under this Section is subject to 0.5 % of AOA limit subject to a minimum of Rs.1000/- and a maximum of Rs.1, 00,000/-

Section XVI : Workmen Compensation

This Section indemnifies the Proposer against liability to its own direct employees, excluding employees of contractors, under the Fatal Accidents Act 1855 / Workman Compensation Act 1923 as amended from time to time and under Common Law to pay compensation in respect of accidental death or injury sustained during the currency of the Policy arising out of and in the course of employment in India.

"Damage" means actual and/or physical damage to tangible property.

"Market Value" means Replacement Value less depreciation.

"Money" means and includes cash, coins, currency notes, cheques, postal orders, bank drafts, pay orders, postage stamps.

"Pollution" means pollution or contamination of the atmosphere or of any water, land or other tangible property.

"**Premises**" shall be deemed to include pipelines running outside the premises for discharge of treated effluents at a disposal point situated within a distance of one kilometer from the Insured's Hotel or Restaurant.

"Retroactive Date" means the date that will coincide with the date of commencement of the first Policy as long as the policy has been renewed without any break. When there is a break, the retroactive date shall commence from the date of renewal of the Policy.

XIII Earthquake (Fire and Shock)

Loss, destruction or damage to any electrical machines, apparatus, fixtures, or fittings arising from or occasioned by over-running, excessive pressure, short circuiting, arcing, self heating or leakage of electricity from whatever cause (lightning included) provided that this exclusion shall apply only to the particular electrical machine, apparatus, fixture or fitting so affected and not to other machines, apparatus, fixtures or fittings which may be destroyed or damaged by fire so set up.

No claim under this Policy shall be payable unless the terms of this condition have been complied with.

(ii) In no case whatsoever shall the Company be liable for any loss or damage after the expiry of 12 months from the happening of the loss or damage unless the claim is the subject of pending action or arbitration; it being expressly agreed and declared that if the Company shall disclaim liability for any claim hereunder and such claim shall not within 12 calendar months from the date of the disclaimer have been made the subject matter of a suit in a court of law then the claim shall for all purposes be deemed to have been abandoned and shall not thereafter be recoverable hereunder.

- 7. On the happening of loss or damage to any of the property Insured by this Policy, the Company may
 - a) Enter and take and keep possession of the building or premises where the loss or damage has happened
 - b) Take possession of or require to be delivered to it any property of the Insured in the building or on the premises at the time of the loss or damage
 - c) Keep possession of any such property and examine, sort, arrange, remove or otherwise deal with the same
 - d) Sell any such property or dispose of the same for account of whom it may concern.

The powers conferred by this condition shall be exercisable by the Company at any time until notice in writing is given by the Insured that he makes no claim under the Policy, or if any claim is made, until such claim is finally determined or withdrawn, and the Company shall not by any act done in the

exercise or purported exercise of its powers hereunder, incur any liability to the Insured or diminish its rights to rely upon any of the conditions of this Policy in answer to any claim.

If the Insured or any person on his behalf shall not comply with the requirements of the Company or shall hinder or obstruct the Company, in the exercise of its powers hereunder, all benefits under this Policy shall be forfeited.

The Insured shall not in any case be entitled to abandon any property to the Company whether taken possession of by the Company or not.

- 8. If the claim be in any respect fraudulent, or if any false declaration be made or used in support thereof or if any fraudulent means or devices are used by the Insured or any one acting on his behalf to obtain any benefit under the Policy or if the loss or damage be occasioned by the willful act or with the connivance of the Insured all benefits under this Policy shall be forfeited.
- 9. If the Company at its option, reinstates or replaces the property damaged or destroyed, or any part thereof, instead of paying the amount of the loss or damage, or join with any other Company or Insurer(s) in so doing, the Company shall not be bound to reinstate exactly or completely but only as circumstances permit and in reasonably sufficient manner, and in no case shall the Company be bound to expend more in reinstatement than it would have cost to reinstate such property as it was at the time of the occurrence of such loss or damage nor more than the sum Insured by the Company thereon. If the Company so elects to reinstate or replace any property the Insured shall at his own expense furnish the Company with such plans, specifications, measurements, quantities and other particulars as the Company may require, and no acts done, or caused to be done, by the Company with a view to reinstatement or replacement shall be deemed an election by the Company to reinstate or replace.

If in any case the Company shall be unable to reinstate or repair the property hereby Insured, because of any municipal or other regulations in force affecting the alignment of streets or the construction of buildings or otherwise, the Company shall, in every such case, only be liable to pay such sum as would be requisite to reinstate or repair such property if the same could lawfully be reinstated to its former condition.

- 10. If the property hereby Insured shall at the breaking out of any fire or at the commencement of any destruction of or damage to the property by any other peril hereby Insured against be collectively of greater value than the sum Insured thereon, then the Insured shall be considered as being his own insurer for the difference and shall bear a ratable proportion of the loss accordingly. Every item, if more than one, of the Policy shall be separately subject to this condition.
- 11. If at the time of any loss or damage happening to any property hereby Insured there be any other subsisting insurance or insurances, whether effected by the Insured or by any other person or

persons covering the same property, this Company shall not be liable to pay or contribute more than its rateable proportion of such loss or damage.

The Insured shall at the expense of the Company do and concur in doing, and permit to be done, all such acts and things as may be necessary or reasonably required by the Company for the purpose of enforcing any rights and remedies or of obtaining relief or indemnity from other parties to which the Company shall be or would become entitled or subrogated, upon its paying for or making good any loss or damage under this Policy, whether such acts and things shall be or become necessary or required before or after his indemnification by the Company.

12. If any dispute or difference shall arise as to the quantum to be paid under this Policy (liability being otherwise admitted) such difference shall independently of all other questions be referred to the decision of a sole arbitrator to be appointed in writing by the parties thereto or if they cannot agree upon a single arbitrator within 30 days of any party invoking arbitration, the same shall be referred to a panel of three arbitrators, comprising of two arbitrators, one to be appointed by each of the parties to the dispute/difference and the third arbitrator to be appointed by such two arbitrators and the arbitration shall be conducted under and in accordance with the provisions of the Arbitration and Conciliation Act, 1996.

It is clearly agreed and understood that no difference or dispute shall be referable to arbitration as hereinbefore provided, if the Company has disputed or not accepted liability under or in respect of this Policy.

It is hereby expressly stipulated and declared that it shall be a condition precedent to any right of action or suit upon this Policy that the award by such arbitrator/ arbitrators of the amount of the loss or damage shall be first obtained.

- 13. Every notice and other communication to the Company required by these conditions must be written or printed.
- 14. At all times during the period of insurance of this Policy the insurance cover will be maintained to the full extent of the respective sum Insured in consideration of which upon the settlement of any loss under this Policy, pro-rata premium for the unexpired period from the date of such loss to the expiry of period of insurance for the amount of such loss shall be payable by the Insured to the Company.

The additional premium referred above shall be deducted from the net claim amount payable under the Policy. This continuous cover to the full extent will be available notwithstanding any previous loss for which the Company may have paid hereunder and irrespective of the fact whether the additional premium as mentioned above has been actually paid or not following such loss. The intention of this condition is to ensure continuity of the cover to the Insured subject only to the right

of the Company for deduction from the claim amount, when settled, of pro-rata premium to be calculated from the date of loss till expiry of the Policy.

Notwithstanding what is stated above, the Sum Insured shall stand reduced by the amount of loss in case the Insured immediately on occurrence of the loss exercises his option not to reinstate the sum Insured as above.

Section II – Alternate Accommodation

This Section provides for payment of expenses of additional rent for alternative accommodation availed of by the Insured in the event of the Insured's Hotel or Restaurant (being the original premises) mentioned in the Schedule to this Policy being destroyed or damaged by fire and allied perils including earthquake and rendered unfit for occupation subject to the following:

- 1. The Indemnity shall be limited to the period during which the original premises remain untenable as a result of occurrence of perils Insured against and shall not exceed six months.
- 2. The liability of the Company shall not exceed the Sum Insured as mentioned in the Schedule to this Policy.
- 3. The additional expenses under this Section shall be the difference between the new and the original rent only.
- 4. Certificate from the Local Municipal Authority or an Architect to the effect that premises in question are untenable is required to be submitted.
- 5. The cover is granted against Fire and allied perils including Earthquake (Fire & Shock). Cover against Riot, Strike, Malicious damage is granted only if it involves actual physical damage to the building. The cover does not intend to pay, if for instance, the Insured's entry is barred by strikers, demonstrators and similar such occurrences.
- 6. The cover is limited to buildings other than those of "Kutcha" construction.
- 7. The area for alternative accommodation shall be equivalent to the area presently occupied by the Insured. However, no restriction will apply in respect of locality for the alternative accommodation, so long as the alternative accommodation is taken in the same city or town.
- 8. Where the Insured is the Owner-Occupant of the present property, since he will not be paying any rent based on the area occupied by him (in comparison with the actual rent being paid by the tenant in the same building or similar buildings in the same locality) the standard rent based on the rateable values fixed by Municipal/Revenue Authorities for tax purposes shall be treated as the original rent for the purpose of this Section.
- 9. If the sum produced by applying the monthly additional rent, borne by the Insured for the alternative accommodation to the maximum indemnity period is more than the Sum Insured hereby, the liability of the Company shall be proportionately reduced.
- 10. If the area of alternative accommodation taken by the Insured is more than the area of the original premises, the additional rent borne by the Insured for the purpose of this Section shall be

deemed to be that proportion of the additional rent actually borne by the Insured as the area of the original premises bears to the area of the alternative accommodation taken by the Insured.

- 11. If the Insured is a tenant only and for safeguarding his legal tenancy rights is obliged to pay rent for the premises even during the period when it is not fit for occupation, the additional rent borne by him shall be the actual rent for the alternative accommodation
- 12. If the Insured is a tenant and is not obliged to pay rent for the premises during the period when it is not fit for occupation, the additional rent borne by him is the actual rent paid for alternative accommodation taken less the rent which he was paying for the premises immediately prior to the same being damaged or destroyed by Insured Perils and rendered unfit for occupation

Special Conditions

- a) The indemnity shall be computed on weekly basis and shall be only for a maximum period of 6 weeks which shall be within three months form the date of occurrence of the Insured peril.
- b) No amount shall be payable under this Section unless the same has been actually incurred by the Insured and is supported by bills / vouchers / receipts/ documents to the satisfaction of the Company.
- c) The amount payable under this Section per week of claim shall not exceed 1% of sum under section 1B of the Schedule attached to this Policy.
- d) Certificate from an Architect to the effect that premises in question are untenantable will be accepted as adequate proof of the fact that the Insured premises have become untenantable.
- e) The temporary location shall be in an equivalent locality, within the same city / town and of a similar extent as the premises that was occupied by the Insured.

Section III – Business Interruption (Fire)

If Insured's Hotel or Restaurant business is interrupted because of damage to the premises by Fire & allied perils and a valid claim is payable under Section 1 of this Policy, the Company will pay for the loss resulting from the interruption in respect of the following items in accordance with the Basis of Settlement and the Limit of Liability.

(a) Gross Profit due to reduction in turnover

(b) Increase in cost of working

DEFINITIONS

- 1. Indemnity Period: The period beginning with the occurrence of the damage and ending not later than number of months specified in the Schedule thereafter during which the results of the business is affected in consequence of damage to the premises caused by Fire & allied perils.
- 2. Turnover: The money paid or payable to the Insured for services rendered in course of the business at the Hotel or Restaurant.
- 3. Gross profit: The amount by which the sum of the Turnover and the amount of Billing shall exceed the sum of the amount of the Opening Billing and the amount of the Specified Working Expenses

Conditions

- 1. If during the Indemnity Period services shall be rendered elsewhere than at the Hotel or Restaurant for the benefit of the business either by Insured or by others on Insured's behalf the money paid or payable in respect of such sales or services shall be brought into account in arriving at the Turnover during the Indemnity Period.
- 2. Insured shall declare within nine months after the expiry of any Period of Insurance, that the Gross Profit earned (or a proportionately increased multiple there of where the maximum Indemnity Period exceeds 12 months) during the accounting period of 12 months most nearly concurrent with the Period of Insurance, as certified by the Insured's Auditors, was less than the Limit of Liability there on, a pro-rata return of premium not exceeding 50% of the premium paid by Insured for such period of Insurance shall be made in respect of the difference. Where, however, The Company does not receive the declaration within twelve months after the expiry of the Period of Insurance, no refund shall be admissible. If any damage has occurred giving rise to a claim under this Policy such return shall be made in respect only of said difference, as is not due to such damage.
- 3. The insurance of this Policy ceases if (a) the business be wound up or carried on by Liquidator or Receiver or permanently discontinued or (b) the Insured's interest ceases otherwise than by death (c) any alteration be made in the Hotel or Restaurant where by the risk of damage is increased, at any time after the commencement of this insurance, unless its continuance be admitted by memorandum signed by or on behalf of the Company.

Basis of Settlement

The amount payable as indemnity shall be

- (a) In respect of loss of Gross Profit due to Reduction in Turnover: the sum produced by applying the Rate of Gross Profit to the amount by which the Turnover during the Indemnity period shall, in consequence of the damage, fall short of the Standard Turnover.
- (b) In respect of Increase in cost of working: the additional expenditure necessarily and reasonably incurred for the sole purpose of avoiding or diminishing the reduction in Turnover which but for the expenditure would have taken place during the Indemnity Period in consequence, but not

exceeding the reduction in turnover so avoided. Less any sum saved during the Indemnity Period in respect of such of the charges and expenses of the business payable out of Gross Profit as may cease or be reduced in consequence of the damage.

Provided that if the Limit of Liability by this item be less than the sum produced by applying the Rate of Gross Profit to the Annual Turnover, the amount payable shall be proportionately reduced.

Departmental Clause

If the business be conducted in departments, the independent trading results of which are ascertainable, the provision of Clause (a) and (b) of Item 1 shall apply separately to each department affected by the damage except that if the Limit of Liability by the said item be less than the aggregate of the sum produced by applying the rate of gross profit for each department of the business(whether affected by the Damage or not) to the relative Annual Turnover thereof, the amount payable shall be proportionately reduced.

Limit of Liability

The maximum amount the Company may have to pay as indemnity under this Section shall not exceed the Limit of Liability in respect of each item as stated in the Schedule for any one Period of Insurance.

Section IV – Electronic Equipment

This Section indemnifies the Insured against any unforeseen and sudden physical loss or damage to Electronic equipment detailed in the Schedule, belonging to the Insured from any cause, other than those specifically excluded, in a manner necessitating repair or replacement, by payment in cash, replacement or repair (at the option of the Company), upto an amount not exceeding during the period of Insurance in respect of each of the items specified in the Schedule the sum set opposite thereto and not exceeding in all the total Sum expressed in the Schedule.

Provided that the Sum Insured in respect of each and every item covered by this Section shall be equal to the cost of replacement of the insured property by new property of the same kind and same capacity,

Replacement cost includes freight, dues and customs duties, if any and erection costs.

Special Exclusions

The Company shall not, however, be liable for

- a) 5% (Five Percent) of the claim amount subject to a minimum of Rs. 1,000/- (One Thousand only) for each and every occurrence of damage.
- b) the Excess stated in the Schedule to be borne by the Insured in any one occurrence whether one or more items are lost or damaged; if more than one item is lost or damaged in one occurrence,

the Insured shall not, however, be called upon to bear more than the highest single excess applicable to such items;

- d) loss or damage as a direct consequence of the continual influence of operation (e.g. wear and tear, cavitations, erosion, corrosion, incrustation) or of gradual deterioration due to atmospheric conditions;
- e) any costs incurred in connection with the elimination of functional failures unless such failures were caused by an indemnifiable loss of or damage to the Insured items;

- i) consequential loss or liability of any kind or description;
- j) loss of or damage to bulbs, valves, tubes, ribbons, fuses, seals, belts, wires, chains, rubber tyres, exchangeable tools, engraved cylinders, objects made of glass, porcelain or ceramics sieves or fabrics, or any operating media);
- k) Aesthetic defects, such as scratches on painted, polished or enamelled surfaces.
- I) The cost of any alterations, improvements or overhauls.
- m) Cessation of work total or partial.

Warranty

It is warranted that an Agreement for the Electronic Equipment Installation from its owners or manufacturers or a Company or Concern approved by manufacturer shall be kept in force throughout the currency of this Policy and no variation in terms of the Agreement shall be made without the Company's written consent. For the purpose of this warranty, 'Agreement' shall mean any agreement which provides:

- a) Maintenance services for the Electronic Equipment Installation including preventive treatment or adjustment of mechanical or moving parts, safety checks and
- b) Rectification of loss, damage, faults arising form any cause during normal operation as well as from aging.

Provided that this warranty shall not apply if the additional premium as required by the Company is paid by the Insured for deletion of this warranty.

Basis of Indemnity:

a) In cases where damage to an Insured item can be repaired the Company will pay expenses necessarily incurred to restore the damaged machine to its former state of serviceability plus the

If the repairs are executed at a workshop owned by the Insured, the Company will pay the cost of materials and wages incurred for the purpose of the repairs plus a reasonable percentage to cover overhead charges. No deduction shall be made for depreciation in respect of parts replaced, except those with limited life, but the value of any salvage will be taken into account. If the cost of repairs as detailed herein above equals or exceeds the actual value of the machinery Insured immediately before the occurrence of the damage, the settlement shall be made on the basis provided below.

- b) In cases where an Insured item is destroyed or cannot be repaired, the Company will pay the actual value of the item immediately before the occurrence of the loss, including costs for ordinary freight, erection and customs duties if any, provided such expenses have been included in the Sum Insured, such actual value to be calculated by deducting proper depreciation from the replacement value of the item. The Company will also pay any normal charges for the dismantling of the machinery destroyed, but the salvage will be taken into account.
- c) The cost of any provisional repairs will be borne by the Company if such repairs constitute part of the final repairs, and do not increase the total repair expenses.
- d) In cases of total loss of the insured item that has become obsolete, all costs necessary to replace the lost or damaged Insured item with a follow-up model (similar type) of similar structure/ configuration (of similar quality) i.e. low, average or high capacity will be reimbursed.
- e) The Company will make payments only after being satisfied, with necessary bills and documents that the repairs have been effected or replacements have taken place, as the case may be. The Company may, however, not insist for bills and documents in case of total loss where the Insured is unable to replace the damaged equipment for reasons beyond their control.

Section V – Reinstatement of Data

This Section indemnifies the Insured against the cost of reinstating data on data carrying materials and for programmes. In the event of damage to data contained in or on data carrying materials or to programmes, up to an amount not exceeding during the period of Insurance the Sum expressed in the Schedule as Insured hereby.

Provided that no claim under this Section shall be admissible unless the data was resident in an electronic equipment covered under Section IV and a claim in respect of the same had been made and admitted by the Company.

Provided further that such reinstatement shall be done within a period of 3 months from the date of occurrence of the loss/ damage.

Special Exclusions

- a) 5% (Five percent) of the claim amount subject to a minimum of Rs. 1,000/- for each and every occurrence of the damage.
- b) Loss caused by data carrying materials not stored in accordance with or stored for a larger period than stated in the maker's instruction.
- c) Any cost arising from false programming, punching, labeling or inserting inadvertent canceling of information caused by magnetic fields.
- d) Loss discovered more than six calendar months after its occurrence.
- e) Cost incurred for alteration or improvement of data/programme.
- f) Intrinsic value of data/programme.
- g) Programme which cannot be exchanged by user

Section VI – All Risk (Portable Computers and Mobile Phones)

The Section will indemnify the Insured against physical loss or damage during the period of this Policy to the items specified in the Schedule and belonging to Insured and in personal custody of Insured, director or employee whilst anywhere in India for the purpose of business.

Provided that the liability of the Company will be limited to Sum Insured against each item in the Schedule and not exceeding in aggregate the total Sum Insured stated in the Schedule in any one period of Insurance.

Provided further that this Section is otherwise subject to the same perils, terms, conditions, exclusions, warranties and provisions as contained in Section IV.

Section VII – Machinery Breakdown

The Company will indemnify the Insured against any unforeseen and sudden physical loss or damage by electrical or mechanical breakdown sustained during the currency of Policy by electrical or mechanical appliances, apparatus, gadgets or any electrical or mechanical installation which are not older than 5 (Five) years in age, while contained in or fixed in the Hotel or Restaurant and specified in the Schedule, from any cause, other than those specifically excluded, in a manner necessitating repair or replacement, by payment in cash, replacement or repair (at the option of the Company), upto an amount stated in the Schedule.

Provided that the Sum Insured in respect of each and every item covered by this Section shall be equal to the cost of replacement of the Insured property by new property of the same kind and same capacity,

Replacement cost includes freight, dues and customs duties, if any and erection costs.

Breakdown shall mean the actual breaking or burning out of or the failure of any part of the appliances, installation specified in the Schedule occurring during normal use owing to any cause stoppage of

functions thereof and necessitating the repair or replacement of such parts before normal working can commence.

Extension

On payment of additional premium this section of the policy is extended to cover any loss or damage due to deterioration, putrefaction or contamination of stocks insured against the breakdown of the Refrigeration Machinery described in the schedule resulting in a rise in temperature in the refrigeration chambers subject to terms, exceptions, warranties and conditions & limit of Liability stated in the schedule.

Special Conditions

- c) If the cost of repairs equals or exceeds the actual value of the insured item immediately before the occurrence of the damage, the settlement shall be made on the basis provided for in d) below.
- d) In case of total loss claims, the Company will pay actual value of the item immediately before the occurrence of the damage including cost for ordinary freight, erection and custom duties if any provided such expenses have been included in Sum Insured. Such actual value to be calculated by deducting 10% depreciation per year from the replacement value of item since date of manufacture. The maximum depreciation however shall not exceed 50% of the replacement value of the item in respect of which is total loss is admitted under the Policy.

Special Exclusions

- f) Damage caused by or arising out of willful act or willful gross negligence of Insured, his employee or director.

- h) Cost of transport to the repair hotel and/or restaurant and back to the Insured's hotel and/or restaurant premises of any Insured item arising out of damage to such item.

Section VIII – Burglary & Housebreaking – Contents (Excluding Money and Valuable)

The Company will indemnify the Insured in respect of:

- a) Loss or damage to contents, by burglary and/or housebreaking
- b) Damage to the Insured's Hotel or Restaurant and/or safe resulting from burglary and/or housebreaking or any attempt thereat subject to a maximum of 5 % of the Sum Insured under this Section.

Provided however that no loss under clauses a) and b) hereinabove, shall together exceed the Sum Insured under this Section.

Basis of indemnity:

- a) The indemnity in respect of contents, other than stock and stock-in-trade, shall be on the basis of reinstatement value or market value, as opted by the Insured. In respect of stock and stock-intrade, it shall be on market value.
- b) In the event of property insured being damaged by any of the insured perils, the Company shall pay for the amount of damage or loss or at its option replace or repair the damaged property.
- c) If the property hereby insured shall, at the time of loss or damage by any of the insured perils covered under this Section, be collectively of greater value than the Sum Insured thereon, then the Insured shall be considered as being his own insurer for the difference and shall bear a ratable portion of the loss accordingly. Every item, if more than one, of the Policy shall be separately subject to this sub-clause.

Special Exclusions:

Section XI – Neon Signs/Glow Signs

The Company will indemnify the Insured in respect of loss or damage to Neon sign/glow sign, belonging to the Insured and fixed in the Hotel or Restaurant by

- a) Accidental External Means
- b) Fire, Lightning, External Explosion or theft
- c) Riot, Strike Malicious Act or Terrorism
- d) Flood, Inundation, Storm, Tempest, Typhoon, Hurricane, Tornado or Cyclone

The Sum Insured shall be on reinstatement value basis. Coverage under this Section is subject to an excess of 5% of the claim amount or Rs 500/- whichever is less, in respect of each and every claim for loss or damage admitted under the Policy.

6. Temporary Total Disablement

If such injury shall be the sole and direct cause of temporary total disablement, then so long as the Insured Person shall be totally disabled from engaging in any employment or occupation of any description whatsoever, a sum at the rate of one percent (1%) of the Capital Sum Insured under this Section hereto per week, but in any case not exceeding Rs. 5,000/- per week in all, under all policies.

Provided that compensation for temporary total disablement shall not be payable for more than 100 weeks in respect of any one injury calculated from the date of commencement of disablement and in no case shall exceed the Capital Sum Insured.

Notwithstanding anything contained in the Policy, the Company shall not be liable for compensation under more than one of the items (1) to (6) hereinabove, in the same period of disablement of the Insured Person.

Special Exclusions

Payment of compensation in respect of death, injury or disablement of the Insured / Insured Person (i) from intentional self injury, suicide or attempted suicide, (ii) whilst under the influence of intoxication, liquor or drugs, (iii) directly or indirectly, caused by venereal diseases, AIDS or insanity, (iv) whilst engaging in aviation or ballooning whilst mounting into, dismounting from or traveling in any aircraft or balloon other than as a passenger (fare paying or otherwise) in any duly licensed standard type of aircraft anywhere in the world (v) arising or resulting from the Insured / Insured Person committing any breach of law with or without criminal intent.

8. Death or disablement resulting, directly or indirectly, caused by, contributed to or aggravated or prolonged by childbirth or pregnancy or in consequence thereof, venereal disease or infirmity.

Payment of compensation in respect of death, injury or disablement of the Insured / Insured Person due to or arising out of or directly or indirectly connected with or traceable to war, invasion, act of foreign enemy, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection, mutiny, military or usurped power, seizure, capture, arrests, restraints and detainments of all Kings, Princes and people of whatsoever nation, condition or quality.

10. Payment of compensation in respect of, death of, or bodily injury or any disease or illness to the Insured / Insured Person directly or indirectly caused by or contributed to by or arising from -

- i) Ionizing radiation or contamination by radioactivity from any nuclear fuel or from any nuclear waste or from the combustion of nuclear fuel and for the purposes hereof, combustion shall include any self-sustaining process of nuclear fission;
- ii) Nuclear weapons material.

11. Any exclusion mentioned in the 'General Exclusions' section of this Policy.

Special Conditions

1. In the event of partial loss or impairment of the function of one of the above parts of the body or senses, the appropriate proportion of the percentage stated in the Table of Benefits will be considered for payment.

2. If the accident impairs a number of physical or mental functions, the degree of disablement given in the Table of Benefits will be added together, but the amount payable shall not exceed 100% of the Sum Insured specified in the Schedule to this Policy.

3. If the accident affects parts of the body or senses whose loss or inability to function is not dealt with above, the governing factor in determining the benefit amount in such a case will be the degree to which the normal physical or mental capabilities are impaired, solely from a medical point of view, as ascertained by Panel Doctor of the Emergency Assistance Service Provider.

4. If the Insured / Insured person dies for a reason unconnected with the accident within a year of the accident for whatever reason, and if a claim for disablement payment had arisen, then the payment will be made in accordance with the degree of disablement which would have been expected to exist from the findings of the last medical examination made, as ascertained by the Panel Doctor of the Emergency Assistance Service Provider.

5. In the event of permanent disablement, the Insured / Insured Person will be under obligation:

- To have himself/herself examined by the Panel Doctors appointed by the Company/Emergency Assistance Service Provider and the Company will pay the costs involved thereof.
- To authorize doctors providing treatment or giving expert opinion and any other authority to supply the Company any information that may be required on the condition of the Insured / Insured Person.

If the above obligations are not met with due to whatsoever reason, the Company shall be relieved of its liability to compensate under this benefit.

Any money of the employee in the hands of Insured and any money which but for the employee's dishonesty would have been due to the employee from the Insured shall be deducted from the amount otherwise payable under this Policy. Any money recovered after the settlement of any claim shall be the property of the Insured, not exceeding, however, the amount paid by the Insured.
- g. The Insured shall when required by the Company but at the expense of the Company if a conviction be obtained, use all diligence in prosecuting any of the employee to conviction for any act which such employee shall have committed and in consequence of which a claim will have to be made under such Policy and shall at the Company's expense give all information and assistance to enable the Company to use for and obtain reimbursement by any such employee by reason of whose acts or defaults a claim has been made or by the estate of such employee or money which the Company shall have become liable to pay in respect thereof.

The Company shall be entitled at its own expense and for its own benefit in the name of the Insured to prosecute all claims and exercise all rights of action competent to the Insured against the employee in respect of any act against Insured in connection with which it may have made payment under this Policy and the Insured shall give to the Company all such information and assistance as may be reasonable for maintaining such claims or rights.

Goods kept in custody of Insured

Legal liability of the Insured for loss / damage to property of residents / bona-fide guests whilst they are under care and control and custody of the Hotel or Restaurant referred to in the Schedule subject to

Legal liability of the Insured for death or bodily injury or loss of or damage to or loss of use of property arising out of accidents (including accidents arising out of contamination of water) in connection with the use of the swimming pool in the Hotel or Restaurant subject to the compliance of the following

- i. Swimming pools in hygienic conditions with regular cleaning and maintenance
- ii. Sanitary arrangements are proper
- iii. Life guards / attendants are on duty when the pools are in use

Sports facilities

Legal liability of the Insured for death or bodily injury or loss of or damage to or loss of use of property arising out of use of sport facilities subject to compliance of conditions that

- a. the equipments are kept in a state of good and proper maintenance
- b. adequate guards and experienced trainers are on duty where necessary
- c. the premises / places used for sports and games are kept in a state of proper maintenance.

Subject to limit of liability not exceeding the following for each of the above covers which shall form part of the overall limit of liability as mentioned in the Schedule of the Policy

Any one accident
